Whereas I, the undersigned, am satisfied that you were in unauthorised occupation of the public premises mentioned in the Schedule below:

And whereas by written notice dated 01.08.2022 (vide Order No 11 dated 25.07.2022) you were called upon to show-cause on/or before 22.08.2022 why an order requiring you to pay a sum of Rs 18,42,969.00 (Rupees Eighteen lakhs Forty two thousand nine hundred sixty nine only.) being damages payable together with compound interest for unauthorised use and occupation of the said premises, should not be made.

And whereas you have not made any objections or produced any evidence before the said date;

Now, therefore, in exercise of the powers conferred on me by Sub-section (2) of Section 7 of the Public Premises (Eviction of Unauthorised Occupants) Act 1971, I hereby order you to pay the sum of Rs. 18,42,969.00 (Rupees Eighteen lakhs Forty two thousand nine hundred sixty nine only.) for the period from 01.10.1992 to 14.10.2010 assessed by me as damages on account of your unauthorised occupation of the premises to Kolkata Port Trust, by 01.11.2022

In exercise of the powers conferred by Sub-section (2A) of Section 7 of the said Act, I also hereby require you to pay compound interest @ 6.65 % per annum, which is the current rate of interest as per the Interest Act, 1973 (as gathered by me from the official website of the State Bank of India) on the above sum with effect from the date of incurrence of liability, till its final payment in accordance with Notification Published in Official Gazette/s.

The fact of the case in a nutshell, as revealed from records, is that the O.P., came into occupation of the Port Property/ Eastern Half of Compartment No. B/1 measuring 86.03 som or thereabouts in the ground floor of the Trustees' Godown, known as Strand Warehouse situate on the West side of Strand Road, Kolkata, under plate no SW 57/1, as a monthly lessee. Thereafter, on ground of certain breaches allegedly committed by the O.P., Eviction Proceeding was initiated by SMPK against the O.P. in the year 1998 before this Forum. The proceeding was culminated into an Order of Eviction dated 15.11.1999. It has been stated by SMPK that before the eviction order could be executed, the subject premises was gutted down by a devastating fire on 14.02.2010 and since the incident of fire the possession of the subject premises is with SMPK. Now, in terms of the said application dated 22.04.2022, SMPK has submitted that huge amount is due and recoverable from O.P. on account of compensation/ damage charges, for O.P.'s use

MAFRASAD MOOKERJEE PORGanesh Shaw, sole proprietor of M/s Shankar Tube Co. Vs BTPC & Ors.) was filed by the sitting occupant, viz. Shri Ram Ganesh Shaw in respect of the subject premises in which Order of Stay was passed and made absolute by the Ld. City Civil Court, Kolkata on 28.06.2004. The said Suit, thereafter, was dismissed on 28.07.2010. In support of such contentions a copy of communication issued by the Ld. Advocate of SMPK dated 02.08.2010 has been enclosed. It is further contended by SMPK that as the said Title Suit had been pending with the stay order for a considerable period of time, SMPK could take no effective steps in the meantime to execute the order of eviction dated 15.11.1999. Thereafter, eventually the subject plot was gutted down by fire on 14.02.2010. It is further contended that an offer letter dated 19.10.2001 was issued to M/s Shankar Tube Co. for grant of direct tendency under SMPK. However, said M/s Shankar Tube Co. failed to comply with the terms and conditions of the said letter. As a result, the issue of granting direct tenancy to them could not be materialised by SMPK authorities.

> Considering the submissions of SMPK, this Forum formed its opinion to proceed against the O.P. and issued Show Cause Notice dated 01.08.2022 (vide Order no. 11 dated 25.07.2022) u/s 7 of the Public Premises (Eviction of

The Notice was issued 17.10.2022 calling upon the O.P. to show cause as to why an order requiring payment of the reported arrear compensation/ damage charges, together with interest, would not be made against the O.P. By Order of THE ESTATE OFFICER SYAMA PRASAD MOOKERJE DORThe said Notice was sent through 'Speed Post' to the CERTIFIED COPY OF THE CADER " FICERecorded address of O.P., viz., '1-A & 1-B, Soveram Basak HASSED BY THE ESTATE PRASAD MOOKET LE PORT Street, Kolkata- 700 007'. However, the notice was returned OFFICERIdelivered by the Postal Department with the remark OF THE LD. addressee cannot be located". STAMA PRASAD MODILE The 'Process Server' attached with this Forum, for service of such Notice/ Order etc., has submitted the Report dated 11.08.2022 intimating failure to serve such notice, as the O.P. was not found on the subject premises. However, it appears from the said Report dated 11.08.2022 that the Notice has been affixed on a conspicuous part of the premises as per mandate of the Public Premises Act, 1971. On the date fixed for filing the reply to show cause, none appeared on behalf of O.P. before this Forum of Law. Then a decision was taken by this Forum to publish a notice in a widely circulated daily English Newspaper as well as in official website of SMPK for a notice to all concerned about the pendency of the instant proceeding in order to provide a further chance to the O.P. to represent its case. Such notice was published in The Times of India (Kolkata edition)' on 07.09.2022 fixing the date for the O.P's appearance, filing reply to Show Cause on 12.09.2022. It appears that on 12.09.2022 neither the O.P. nor anyone interested in the property approached the Forum or made a contact in the meantime, in connection with the Show Cause Notice issued by this Forum. Thus inspite of such efforts being made none appeared on behalf of O.P. and all the efforts remained futile. Considering the

O.P. in respect of the premises for decades together. In my view, such statements maintained by a statutory authority/ SMPK in its usual course of business has definite evidentiary value, unless challenged with fortified documents/evidences etc, ready to bear the test of legal scrutiny. During the course of hearing, I am given to understand by SMPK that the rent as well as compensation/ damages charged from time to time is based on the rates notified by the Tariff Authority for Major Ports (TAMP) in the Official Gazette, which is binding on all users of the port property. Non-payment of dues by O.P. for decades together is very much prominent and established, as discussed above. Hence, I have no bar to accept the claim of SMPK on account of damages/compensation charges. I have nothing to disbelief in respect of SMPK's claim against O.P. as per statement of accounts maintained regularly in SMPK's office in regular course of business.

Thus, it is my considered view that a sum of Rs. 18,42,969.00 (Rupees Eighteen Lakhs Forty Two Thousand Nine Hundred Sixty Nine only) is due and recoverable from the O.P. for the period from 01.10.1992 to 14.10.2010 by

Interest is the natural fallout for delayed payments of Rent/Compensation and as such, the O.P. is liable to pay interest for the same. Such dues attracts Compound Interest @ 6.65 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered from the official website of the State Bank of India) from the date of incurrence of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMPK's books of accounts.

The formal order u/s 7 of the Act is signed accordingly.

I make it clear that in the event of failure on the part of O.P. to pay the dues/charges as aforesaid; SMPK is at liberty to recover the dues etc. in accordance with law.

All concerned are directed to act accordingly.
