Premises specified in the Schedule below :

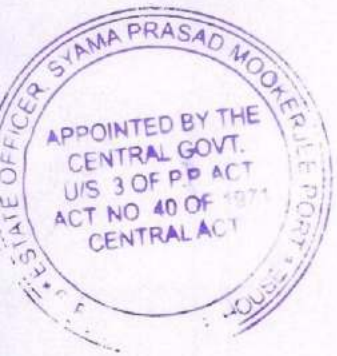
**REASONS**

Kolkata: 700 043** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

## FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. D/10 at Nimak Mahal Mazdoor Line. The said quarter was declared condemned on 14.05.2001. The quarters were to be disposed of alongwith latrine blocks, rest shelters, wresting pits by way of tender by the Civil Engineering Department. The land as would be available after the disposal of the quarters would be utilised for gainful utilisation for commercial purposes by SMPK (erstwhile Kolkata Port Trust). As and when the said Mazdoor Line were being vacated by the authorised Class IV allottees of the quarters in gradual stages, the O.P. trespassed into the said quarters and occupied it unauthorisedly and has been using the same since 2005.

On 19.04.2005, an application was filed by SMPK praying for eviction of O.P. An application was filed by SMPK on 03.05.2022, stating the quarters in question is still under the unauthorised occupation of O.P.

I am appalled by the fact that since then almost 18 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 07.04.2022. The said Show Cause notice along with the order dated 07.04.2022 were sent

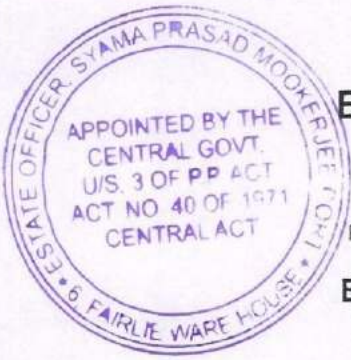

through "Speed Post" to O.P. The envelope was returned back by the Postal Department. The order along with notices were also served upon O.P.s through Process Server. It is seen from the report of the process server that the Door of the premises was found closed. However, due affixation of the order was made on a conspicuous part of the premises for notice to all concerned. In spite of which none appeared for O.P. I am satisfied with the service of notice.

In course of hearing in spite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P.s or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P. or anyone else
- (b) That nothing has been shown in support of O.P.'s occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P.,
