

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 13 Bl. No. A at K.F. Shipping Mazdoor Line. The said quarter was under lock and key since 08.01.1996. On or about 18.06.2001, Md. Ashraf, the Opposite Party, hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock. Since then O.P. had been unauthorisedly occupying the said quarters without any authority. SMP,K vide application dated 04.01.2021 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by another rank outsider being Md. Shahensah.

SMPK filed application dated 18.06.2002, praying for an order of eviction against O.P. I am appalled by the fact that the matter is pending without adjudication for so long. Be that as it may, this Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 22.02.2021. The said Show Cause notice along with the order dated


