ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Dasarath Show & D.N. Shaw, Qtrs.15 Block No. 40 at Hide Road P.S. South Port Police Station. Kolkata-700 043 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.s
- 2) That nothing has been shown in support of O.P.s' occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P.s as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.P.s' occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.



A copy of the reasoned order No.09 dated 09.02.20.23 is attached hereto which also forms a part of the reasons.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Shri Dasarath Show & D.N.**Shaw, Qtrs.15 Block No. 40 at Hide Road P.S. South Port Police Station. Kolkata- 700 043 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Shri Dasarath Show & D.N. Shaw, Qtrs.15 Block No. 40 at Hide Road P.S. South Port Police Station. Kolkata- 700 043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 15 Block no.40 at Hide Road Mazdoor Road. The said quarter was under lock and key since 30.11.1998. On or about 08.07.2000, one Sri Dasarath Show, the Opposite Party No.1 hereinafter referred to as O.P.No.1 forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMPK on 04.08.2000, praying for eviction of O.P. A query was made by the Forum on 20.05.2022, asking SMPK about the present status of the subject property. Vide application dated 01.08.2022, it was submitted by SMPK that one Sri D.N. Shaw, rank outsider is still in possession of the subject quarters and prayed for eviction proceedings to be drawn up against him. Forum on the basis of the information issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 25.08.2022. The said Show Cause notice along with the order dated 25.08.2022 were sent through "Speed Post". The envelopes, were returned with the remark "Refused". The said order was also sent through Process Server. It is seen from the report of the Process Server dated 30.08.2022, that the order was received on behalf of O.P. Due affixation was also made in the conspicuous part of the premises for notice to all concerned. Inspite of having knowledge of the pending proceedings neither of the O.P.s nor anyone interested in the said property appeared before the Forum to place their submissions. For the sake of natural justice, another chance was given to O.P. to represent their case before the Forum. Order dated 12.09.2022, was sent to O.P. through Process Server. It is seen from the report

of the Process Server dated 29.09.2022, that order dated 12.09.2022 was duly served upon O.P. and due affixation of the order was also made on a conspicuous part of the premises. As none appeared on behalf of O.P., yet another chance was given to O.P. to represent his case before the Forum. Order dated 10.10.2022 was sent to O.P. by Speed Post. The envelope has been returned with the remark "No such in the address". The order was also sent through "Process Server". It is seen from the report of the Process Server dated 28.10.2022, O.P. refused to take service of the order. However, due affixation of the order was made on a conspicuous part of the premises for notice to all concerned. Inspite of such repeated services, none appears for O.P. I am satisfied with the service of notice.

Inspite of having knowledge of the pending proceedings neither of the O.P.s nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelie on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P.s or anyone else
- (b) That nothing has been shown in support of O.P.s' occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P.s as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;

(e) That O.P.ss occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
