**ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC
PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971**

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that **Shri Bablu & Md. Izhar, Quarters No. 14, Block No. 31, Hide Road Mazdoor Line, P.S. S.P.P.S., Kolkata- 700 023**, is in unauthorized occupation of the Public Premises specified in the Schedule below :

REASONS

- 1) That no reply to the Show Cause notice is filed by the O.P.s
- 2) That nothing has been shown in support of O.P.s' occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P.s' as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.P.s' occupation is unauthorized in all respect and O.P.s' have failed to make out any case in support of his occupation.


NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Shri Bablu & Md. Izhar, Quarters No. 14, Block No. 31, Hide Road Mazdoor Line, P.S. S.P.P.S., Kolkata- 700 023** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the **Shri Bablu & Md. Izhar, Quarters No. 14, Block No. 31, Hide Road Mazdoor Line, P.S. S.P.P.S., Kolkata- 700 023** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust), applicant, herein, that all along SMP,K is the owner of the of Quarter No. 14 Bl. No. 31 at Hide Road Mazdoor Line. The said quarter was under lock and key since 03.07.2001. On or about 10.09.2001, Shri Bablu, the Opposite Party No. 1, hereinafter referred to as O.P.No.1 forcibly occupied the above quarters by breaking open the padlock. Since then O.P. No.1 had been unauthorisedly occupying the said quarters without any authority.

SMPK filed application dated 18.01.2002, praying for an order of eviction against O.P.No.1. Upon direction being passed by the Forum on 20.05.2022, SMP,K vide application dated 11.08.2022 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by rank outsider namely Md. Izhar, Opposite Party no. 2, hereinafter referred to as O.P. No. 2 and prayed for an eviction proceedings being initiated against the said O.P. No. 2. This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 25.08.2022 upon O.P. no.1 & 2. The said Show Cause notice along with the order dated 25.08.2022 were sent through "Speed Post". The envelope, however has not been returned showing good service of the order. The Track Consignment Report of the India Post shows that the item was delivered. The order were also sent through Process Server attached to the Forum. It is seen from the report of the Process Server dated 30.08.2022, that order

was duly received on behalf of O.P. Due affixation was made on a conspicuous part of the public premises for notice to all concerned. As none appeared on behalf of O.P. No. 1 and O.P. No.2, for the sake of natural justice, another opportunity was given to O.P.s to represent their case before the Forum. Order dated 12.09.2022, was sent through the Process Server. It is seen from the report of the Process Server dated 29.09.2022, that the order was duly received on behalf of O.P. on 29.09.2022 and due affixation was also made on a conspicuous part of the premises for notice to all concerned, inspite of which none appeared. Another chance was again given to O.P. No. 1 & 2 vide order dated 10.10.2022, asking them to appear before the Forum on 14.11.2022. It is seen from the Report of the Process Server dated 29.10.2022, that O.P. refused to accept the service of the order, however, due affixation of the order was made on a conspicuous part of the premises, inspite of which none appeared before the Forum to represent their case. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P.s nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P.s or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelieve on the statements made by SMPK before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P.s or anyone else
- (b) That nothing has been shown in support of O.P.s' occupation into the premises;

- (b) That nothing has been shown in support of O.P.s' occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P.s' as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.s' occupation is unauthorised in all respects and O.P.s' have failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
