WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Munshi Jadav,Qtrs. No. 12, Block No. 20, Hide Road Mazdoor Line, P.S. S.P.P.S., Kolkata- 700 043 is in unauthorized occupation of the Public Premises specified in the Schedule below:

#### REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P's occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.P's occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

S.P.P.S., Kolkata- 700 043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

#### FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 12 Bl. No. 20 at Hide Road Mazdoor Line. The said quarter was under lock and key since 22.12.1999. On or about 18.05.2000, Munshi Jadav, the Opposite Party, hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock. Since 'then O.P. had been unauthorisedly occupying the said quarters without any authority. SMPK filed an application dated 21.06.2000 praying for an order of eviction against O.P. I am appalled by the fact that since then almost 23 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971. SMP,K vide application dated 25.04.2022 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by one Lila Devi and Subash Yadav, rank outsiders.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthosied Occupant) Act, 1971 (hereinafter referred to as The Act) on 16.08.2022. The said Show Cause notice along with the order dated. 16.08.2022 were sent through "Speed Post". The envelope has been returned back showing with the remark "No such

person the address". The Show Cause notice along with the order were also sent through Process Server. It is seen from the report of the Process Server dated 18.08.2022 that O.P. refused to the order. It is further seen from the Report of the Process Server that due affixation of the order along with the Show Cause Notice dated 16.18.2022, was made on a conspicuous part of the premises. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

(a) That no Reply to the Show Cause has been filed by O.P. or anyone else

- (b)That nothing has been shown in support of O.P.'s occupation into the premises;
- (c)That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d)That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
