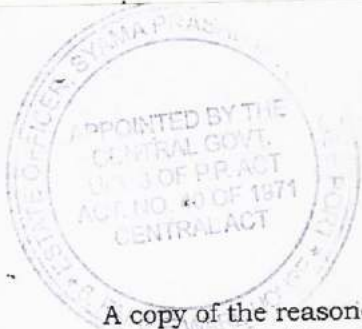

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that **Shri Satyendra Singh & Sri Umesh Bin, residing at Quarters No.8, Block No.06, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata - 700 043**, is in unauthorized occupation of the Public Premises specified in the Schedule below :

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P's occupation into the public premises.

In the event of refusal or failure to comply with this order within the period specified above the said **Shri Satyendra Singh & Sri Umesh Bin, residing at Quarters No.8, Block No.6, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata - 700 043** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.





FINAL ORDER

The matter is taken up today for hearing. The matter is taken up for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 8 Bl. No. 6 at Hide Road Mazdoor Line. The said quarter was under lock and key since 20.08.1996. On or about 02.07.2000, one Sri Satyendra Singh, the Opposite Party, hereinafter referred to as O.P. No.1 forcibly occupied the above quarters by breaking open the padlock. Since then O.P. had been unauthorisedly occupying the said quarters without any authority. An application was filed by SMPK

Thereafter on 19.10.2022, SMP,K submitted that on a recent inspection it was found that the subject quarter is still under the unauthorised occupancy of one Umesh Bin.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 02.01.2023. The order along with the notice dated 02.01.2023, was sent to O.P. calling upon him to appear before the Forum and file his reply to the show cause notice. Such order was sent through Speed Post. However, the envelope has been returned with the remark " no such person in the address".

It is seen from the report of the Process Server dated 09.01.2023, that O.P. refused to accept the order. However, due affixation was made on a conspicuous part of the public premises for notice to all concerned. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMPK before the Forum.

Accordingly the order of eviction is issued on the following grounds/ reasons;

- (b) That nothing has been shown in support of O.P. occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P. occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
