- 5) That O.P.'s occupation is unauthorized in all respect and O.P.s have failed to make out any case in support of his occupation.

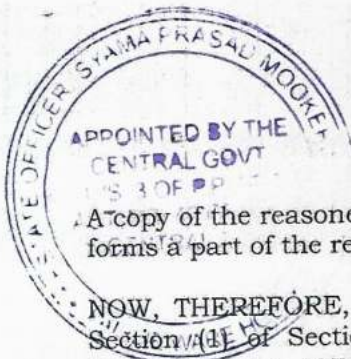

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Sri Samin Ali, Qtrs. 10 Block No. K at K.F. Shipping Mazdoor Line P.S. SPPS, Kolkata- 700 023** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said **Sri Samin Ali, Qtrs. 10 Block No. K at K.F. Shipping Mazdoor Line P.S. SPPS, Kolkata- 700 023** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

**FINAL ORDER**

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 10 Block no. K at K.F. Shipping Mazdoor Line. The said quarter was under lock and key since 17.12.1997. On or about 15.06.1999, one Sri Samin Ali, the Opposite Party forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMPK on 22.02.2000, praying for eviction of O.P. Forum on the basis of the information issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 26.02.2004. The said order was sent through Process Server. It is seen from the report of the Process Server dated 16.03.2004, that the O.P. duly received the order. Due affixation was also made in the conspicuous part of the premises for notice to all concerned inspite of which none appeared for O.P. An application was filed on 05.03.2021, by SMPK stating that the quarter in question is still under the unauthorised occupation of one rank outsider. For the sake of natural justice vide order dated 20.10.2022 another chance was given to O.P. to represent his case before the Forum. The order was sent through Speed Post. The envelope, has been returned by the postal Department with the remark "Addressee cannot be located". The order was also sent through Process Server. It is seen from the report of the Process Server dated 26.10.2022, that O.P. refused to take service of the order. Due affixation was also made in the conspicuous part of the premises for notice to all concerned inspite of which none appeared for O.P. I am satisfied with the service of notice.

Inspite of having knowledge of the pending proceedings neither of the O.P.s nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In

view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelieve on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P. or anyone else
- (b) That nothing has been shown in support of O.P.'s occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
