





The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 10 Block no. E at K.F. Shipping Mazdoor Line. The said quarter was under lock and key since 24.05.2001. On or about 14.06.2001, one Md. Akhtar Khan, the Opposite Party No.1 forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMFK stating that the quarter is still under the unauthorised occupation of Sri Id. Mohammad, another rank outsider hereinafter referred to as O.P. N. 2 and prayed for his eviction. Forum basis of the information issued a Notice to Show Cause under Section 4 of the Public Premises (Evidtion of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 21.12.2020. The said order was sent through Speed Post. The envelope has been returned with the remark "Insufficient Address". The said order was sent through Process Server. It is seen from the report of the Process Server dated 14.01.2021, that the Door of O.P. was found closed. However, due affixation of the order was made on a conspicuous part of the premises for notice to all concerned. For the sake of natural justice another chance was given to O.P. to represent their case before the Forum. or the sake of natural justice, vide order dated 01.03.2021 another chince was given to O.P. to represent their case before the Forum. The said order was sent through Process Server. It is seen from the report of Frocess Server dated 24.03.2021 that O.P.s did not allow the process server to enter and threatened to assault in case they would visit the premises again. Affixation also could not be made by O.P. as the O.P.s it not allow them affix the same. I am

In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelieve on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"

- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
