No escalation will be allowed. **Unloading & Stacking at site of HDC would be in account of P&E Division, HDC at their own cost, risk and responsibility.**
- 2.0 GST:**
Extra as applicable at the time of delivery, presently, @18%.
- 3.0 DELIVERY TIME:**
Delivery of the materials must be completed within 09 (Nine) months from the date of receipt of order by you at the site /store of Haldia Dock Complex.
- 4.0 DELIVERY PLACE:**
Store/site of Ore & Coal handling Plant under control of P&E Division, of Haldia Dock Complex, HDC, Haldia, West Bengal, India.
- 5.0 PAYMENT:**
100% payment will be made against dispatch documents through bank.
- 6.0 CERTIFICATES:**
You should submit Warranty and Fitment Certificate along with supplies.
- 7.0 INSPECTION:**
Inspection of Spare Parts will be done by the Engineer of P&E Division, HDC at store/site of O&CH Plant under control of P&E Division, after delivery of materials.
- 8.0 WARRANTY AND FITMENT:**
The materials to be supplied must be Guarantee/Warranty and it would be (inclusive of latent defect liability) 12 months from the date of supply.
- 9.0 TRANSIT RISK :**
Transit risk will be on your account since the delivery is to be made on F.O.R. Destination basis.

LD will be levied @ ½% per week on the value of the delayed portion subject to maximum of 10% of total basic value of order and GST would be chargeable extra on LD as applicable.
