- b) The duties include attending to outdoor, indoor and emergency patients/ performing operations independently, etc.

- c) Free board and lodging at KoPT Guest House, Haldia and free transportation by car between Kolkata (within municipal limits) and Haldia will be provided.
- d) Duration of visit at HDC Hospital and other terms & conditions will be informed / as agreed to by the applicants at the time of interview before the Interview Board.

General terms & conditions for Medical Specialists (on contract):-

- i) The Medical Specialists will be posted at KoPT Hospital at Haldia.
- ii) The engagement will be for a period of 1 (one) year. However, on expiry of the contract, HDC/KoPT reserves the right to enter into a fresh contract for such period and on such terms as may be mutually agreed upon by the parties.
- iii) The selected candidate shall be responsible for carrying out medical treatment/ investigation, both indoor and outdoor, including conducting operations, as required. He / She shall have to perform any other work, as may be assigned by the Medical Superintendent.
- iv) The assignment is residential and, accordingly, the selected candidate shall be required to stay in the accommodation (unfurnished) provided by HDC / KoPT, free of rent, at Haldia. Electricity charges shall have to be borne by the selected candidate, at actuals. Alternatively, free Guest House accommodation (single) may be provided.
- v) The selected candidate will be provided with residential telephone, as applicable.
- vi) The office of the selected candidate will be at the Port Hospital of Haldia Dock Complex at Haldia Township, Dist-Purba Medinipur-721 607.
- vii) The selected candidate shall be required to work on full time basis for 6 days in a week and will normally be entitled to a weekly off day. For work on any weekly off day / declared National Holiday in exigency, the candidate will be granted a compensatory day of rest conveniently in lieu thereof and he will not be entitled to any other compensation, monetary or otherwise, for the same. The selected candidate shall also have to attend to emergency calls, as per requirement, beyond their normal duty hours, without any extra remuneration for the same.
- viii) The selected candidate will be entitled to 15 days' leave in a year (12 months from the date of engagement and proportionate in case of shorter period of engagement) which shall be availed of with prior approval. For any absence, in excess of 15 days, pro-rata deduction will be made from the consolidated remuneration.
- ix) Additionally, sick leave, to the extent of 10 days in a year (12 months from the date of engagement and proportionate in case of shorter period of engagement) on illness, shall be allowed without any deduction from the remuneration on the basis of certification from HDC Medical Officer. - x) The selected candidate will be entitled to indoor & outdoor medical facilities as are available in HDC Hospital for self & spouse only. However, no re-imburement for medicine / medical articles purchased from outside, diagnostic tests done outside or treatment received outside will be allowed.
- xi) On official tour outside headquarters of Haldia Dock Complex, the selected candidate would be entitled to TA/DA as applicable to the regular incumbents in the post of Dy. Medical Supdt.
- xii) Medical Superintendent, HDC will be the Reporting Officer.
- xiii) The selected candidate will be entitled to avail the canteen facility of HDC.
- xiv) The selected candidate shall be responsible for the charge and care of HDC / KoPT's money, goods and stores and all other property that may be entrusted on him and he will be accountable for the same.
- xv) The contractual engagement may be terminated by giving one month's notice from either side. However, the engagement is terminable with 24 hours' notice for unsatisfactory performance and for any act considered to be derogatory / detrimental to the interest of HDC / KoPT.

Eligibility Criteria

(i) Age:

(ii) Qualification & Experience:

The candidate must possess MBBS Degree from a recognized University / Institute with a minimum of 1 year experience after internship. Preference will be given to candidates having experience in ICU of a hospital of repute.

(iii) Remuneration:

Fixed remuneration of Rs. 50,000/- Per month

Other Terms & Conditions of contractual engagement of General Duty Medical Officer

- i) The General Duty Medical Officer will be posted at KoPT Hospital at Haldia.
- ii) The engagement will be for a period of 1 (one) year and on expiry of the said period, the contractual engagement will be automatically terminated. However, on expiry of the contract, HDC / KoPT reserves the right to enter into a fresh contract for such period and on such terms as may be mutually agreed upon by the parties.
- iii) The selected candidate will be responsible to carry out medical treatment in Indoor / Outdoor / ICU / Emergency / Dispensary, as required, under the Port Hospital of HDC, Haldia. He / she will generally be deployed in shifts.
- iv) The selected candidates will be paid a fixed remuneration of Rs.50, 000/- per month.
- v) The selected candidate shall be required to stay in the accommodation (unfurnished) provided by KoPT free of rent. Electricity charges shall have to be borne by the selected candidate, at actual.
- vi) The office of the selected candidate shall normally be at the Port Hospital of Haldia Dock Complex at Haldia Township, Dist.: Purba Medinipur – 721607.
- vii) The selected candidate will be required to work in shifts on rotation i.e. morning, afternoon and night, as per the requirement. The candidate may also be required to work in general shift duty, if situation so warrants. He will have to work for 6 days in a week and will be given a staggered weekly day of rest. If situation so warrants, the weekly day of rest may be changed with prior intimation. For work on any weekly off day / declared National Holiday in exigency, the candidates will be granted a compensatory day of rest conveniently in lieu thereof and they will not be entitled to any other compensation, monetary or otherwise, for the same. The candidates will also have to attend emergency calls as per requirement, beyond their normal duty hours without any extra remuneration for the same.

- xii) The selected candidate would be entitled to avail the canteen facility as is available to the regular employees of HDC.
- xiii) Normally, Medical Superintendent, HDC will be the Reporting Officer for the selected candidates.
- xiv) The selected candidate shall be responsible for charge and care of HDC / KoPT's money, goods and stores and all other property that may be entrusted on them and they will be accountable for the same.
