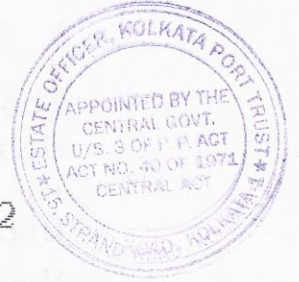

Proceedings against M/s Roy Coal Concern, the O.P. herein, have been initiated u/s 4 & 7 of the P.P. Act for adjudication of the prayer of Kolkata Port Trust (KoPT) for order of eviction in respect of Kolkata Port Trust's plot being land measuring 205.037 sqm. situated at Chetla Station Yard, P.S. Chetla.

It is worthy to point out that Postal Service to O.P. herein was returned undelivered with the remarks of the Postal Department as "Not Known". It is further to be mentioned that Process Server could not effect service on O.P. however due affixation was made on property.

NOW THEREFORE, in exercise of the power conferred upon me, I hereby give notice to all concerned interested in the property under schedule to file reply to the Show Cause Notice on or before 31.07.2018 and to appear before me on 31.07.2018 at 12 noon. either in person or through authorised representative (along with a letter of authority) capable of answering all material questions in respect of the property described under the Schedule below, failing which the matter will be decided exparte without any further reference.
