Sir,

Sub-: Filling up of the post of Dy. Harbour Master (Port) by absorption through composite method at KDS, KoPT – applications invited.

Applications are invited for filling up of the post of Dy. Harbour Master (Port) in the scale of pay of Rs. 43,200-66,000/- at Kolkata Port Trust (Kolkata Dock System) by absorption through Composite Method, as per enclosed Recruitment Rules (at Annexur-1).

As per Recruitment Rule, the post is to be filled up by absorption through composite method from officers holding analogous post or the post of Dock Master/Commander Pilot Vessel and equivalent post with 2 years regular service either as Dock Master or in the post of Dock Master/Commander, Pilot Vessel and Mooring Master taken together in the grade for 2 years in a Major Port Trust..




