Sub: Noticing of trucks without proper Head Light or Tail Lamp.

In continuation of this office Circular of even no. dated 21.12.2018 it has been decided that on and from 01.01.2019 all Dock Workers who are entering Netaji Subhas Dock (NSD) section have to wear PPE and must abide by all safety norms. In continuation of that it has also been decided that all Heavy Duty Vehicles entering Docks should abide by all safety requirement and must be equipped with effective brakes, head lights, tail lamps etc. and are maintained in good repairs and working order in terms of regulation no.57(3) under Dock workers (Safety, Health & welfare) Regulation 1990. It may further be noted that during inspection Dock Safety had found a good number of vehicles which are not equipped with brakes, head lights, tail lamps etc and not found in good repairs and working order. Serious objections in this regard have been raised by Dock Safety.

Accordingly, it has been decided that on and from 01.02.2019 no vehicle should enter Port Area without fulfilment of above requirement. If any vehicle is found with any shortcomings in this regard, same will be blacklisted for 05 (five) days in first instance and will be allowed access only after confirmation in writing that necessary repairing of the vehicle has been undertaken. It may further be noted that in case of repetition, the same vehicle will be blacklisted for 01 (one) month in subsequent occasion.
