Applications are invited for 2 posts of Commander, Dredger and Despatch Service under Marine Department – by deputation

Applications are invited for filling up 2 posts of Commander, Dredger and Despatch Service (D&D Service) in the scale of pay of Rs. 36,600 – 62,000/- by deputation. The posts of Commander (D&D Service) are responsible for operation of KoPT – owned Dredger and Despatch Vessels including its manning, maintenance, etc. The KoPT Dredger is required to sail down the River for maintenance dredging in the Shipping Channel of this Port for a period of 15 days at a stretch. After returning to town, the Dredgers undergo routine maintenance and sail out for next assignment thereafter. KoPT own Despatch Vessel carries out laying, Servicing and maintenance of navigational buoys, lights used for demarcation of Shipping Channel. In addition, Despatch Vessel is used for assisting Vessels in distress including supply of water etc.

Commander, D& D Service is also posted on-Board the Contractual Dredgers of DCI and other private Dredger engaged for maintenance Dredging in Hooghly estuary, for supervision of Dredging work round-the-clock, including certifications of the work carried out by the Contractor. Their posting on Board hired Dredgers also fulfils the requirement of relevant Regulations under Indian Ports Act.

Educational and other qualification required:-

Candidates possessing Master's (FG) certificate or service certificate as Master (FG) from Indian Navy or Dredge Master Grade-I certificate. A copy of the RR is enclosed herewith. (Annexure-I).

Note:

A candidate processing Master's (FG) certificate or service certificate as Master (FG) from Indian Navy or Dredge Master's Gr.I certificate shall enter the Dredger & Despatch Service of the Kolkata Port Trust directly as Commander (on training). After undergoing necessary training and passing necessary examinations as prescribed for them in the Scheme for training of Officers in the Dredger & Despatch Service of Kolkata Port Trust, they shall be eligible for independent Command. Serving Commander from Hydrographic Service will also be eligible for the post of Commander D & D Service
