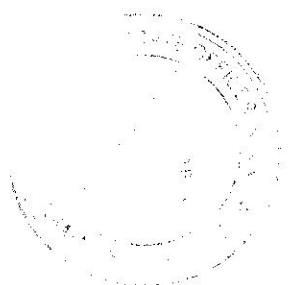

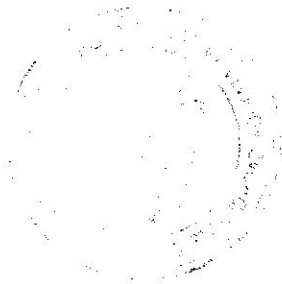


SCHEDULE

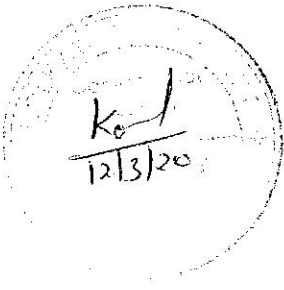
