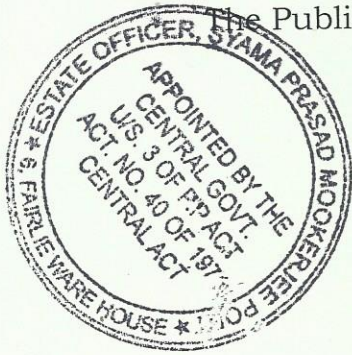

Whereas, Proceedings against Smt. Manorama Devi being Proprietor of Mahalaxmi Coal Traders, the O.P. herein, have been initiated u/s 4 & 7 of the P.P. 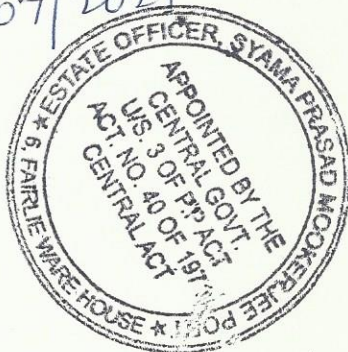
SCHEDULE
