Goomty No. 90 msg. about 4.18 Sq.m is situated near Gate No. 7 at Kolkata Jetty in the presidency town of Kolkata.

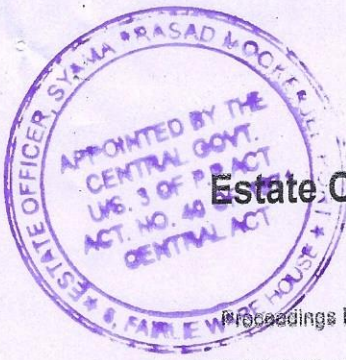


The matter is taken up for hearing today. None appears on behalf of O.P. to file reply to the Show Cause Notice dated 03.12.2021. It is seen from the records that the Show Cause Notice dated 03.12.2021 passed under Section 7 by this Forum was sent to O.P. through 'Speed Post' at the recorded address of O.P. and the same had returned back on 06.12.2021. The Show Cause Notice was also sent by the Department's Process Server by hand delivery but the same could not be served upon O.P. due to O.P.'s absence from the subject premises. The Show cause Notice was then affixed at the subject premises and the same is evident from the Process Server's report of this Forum.

It is further seen from the records that Department was also directed to publish a Notice in a Hindi Daily having wide circulation for information to the O.P. to file reply to the Show Cause Notice dated 03.12.2021 and thereby directed to appear before this Forum for hearing on 16.12.2021. But due to an inadvertent error the Notice could not be published in a Hindi Daily News Paper.

In view of such circumstances let the matter be re-fixed for hearing and for filing of reply by O.P. to the Show Cause Notice dated 03.12.2021. Department is directed to publish a Notice in an Hindi Daily News Paper in classified column having wide circulation and as well as in the Website of Syama Prasad Mookerjee Port, Kolkata at the earliest for information of the O.P. and/or any person interested in the subject Public Premises regarding the pendency of the present proceeding.

Through this Publication, O.P. is directed to appear before this Forum of Law on 03.02.2022 at -11-A.M. either in person or through authorised representative (alongwith an authorisation letter) and file written reply to the aforesaid Show Cause Notice in respect of the subject Public Premises, failing which the matter shall be decided *ex-parte* without any further reference.

Let the matter come up for hearing, submission, production of documents, consideration etc. on 03.02.2022 at -11-A.M. All concerned are directed to act accordingly.
