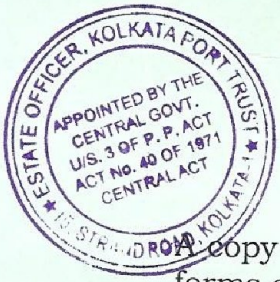
**R E A S O N S**

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Sri Jamal & Sri Sk. Jamula (hereinafter referred to O.P No.1 & O.P No. 2) both of Quarters No.15, Block No. D, K.F. Shipping, P.S: S.P.P.S., Kolkata-700023** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said **Sri Jamal & Sri Sk. Jamula (hereinafter referred to O.P No.1 & O.P No. 2) both of Quarters No.15, Block No. D, K.F. Shipping, P.S: S.P.P.S., Kolkata-700023** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

On the North by: K.F. Shipping Quarters;



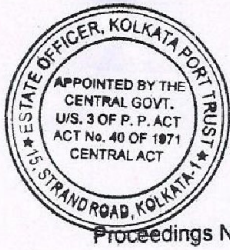
#### FINAL ORDER

The matter is taken up today for delivering the final order. It is the case of **Syama Prasad Mookerjee Port, Kolkata** [earstwhile **Kolkata Port Trust/ KoPT** (hereinafter referred to as '**SMPK**'/ '**Port Authority**'), applicant herein, that Quarter No. 15, Block No .D at K.F. Shipping Mazdoor Line, P.S. South Port Police Station, Kolkata- 700 023 was under lock and key of SMPK since 19.08.1994. However, one **Sri Jamal** (hereinafter referred to as **O.P. No. 1**), rank outsider forcibly occupied said Quarter by breaking open SMPK's padlock on or about 02.07.1999 and since then the O.P. No 1 was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one **Sri Sk. Jamula** (hereinafter referred to as **O.P. No. 2**), who is also a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against both O.P. No 1 and 2 by issuing the Show Cause Notice dated 12.01.2021 (vide Order no 04 dated 21.12.2020) for adjudication of the prayer of eviction, under the relevant provisions of **Public Premises (Eviction of Unauthorized Occupants) Act, 1971** (hereinafter referred to as '**the Act**') and the Rules made thereunder. The O.P. no 1 & 2 were called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intends to produce in support of their case.

The said Notice was sent through 'Speed Post' to the Quarter address of the O.P., however, the notice was returned undelivered by the Postal Department. The 'Process Server' attached with this Forum has submitted his report dated 20.01.2021 intimating that the service of the notice has not been effected as the door of the subject quarter was closed on that day. However, the Notice was affixed on the property in question, as per the mandate of the Act, as it appears from the said report of Process Server dated 20.01.2021. In spite of such efforts made, the appearance of O.P. could not be procured and the efforts remained futile. Following the principles of natural justice, further two attempts were made to serve such notice in terms of Order dated 25.01.2021. However, such effort was also went into vain as it appears from the report of 'Process Server' dated 25.02.2021 and 01.04.2021 that the parties did not allow to enter and refused to take the order. But, this time also the Notice was affixed on the property in question, in terms of the mandate of the Act.

In spite of such efforts, nobody appeared before me with any authority to stay into the quarters in question. Considered the report of the Process Server dated 20.01.2021, 25.02.2021 and 01.04.2021 regarding affixation of Show Cause Notice u/s 4 of the Act on the property in question. I am satisfied with the service of notice to all concerned. No reply to the Show Cause Notice u/s 4 of the Act dated 12.01.2021 on behalf of either O.P. no 1 or O.P. no 2 has been filed. As such, I have nothing to disbelieve the statements made against both the O.P.s by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and Port Authority is entitled to claim damages for unauthorized use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
