ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Md. Alam & Anr. Qrs.No. 6, Block No. A, K.F. Shipping, P.S: S.P.P.S. Kolkata – 700 023 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1. That nothing has been shown in support of O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of O.P. as "authorized possession/occupation".
- 3. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 4. That the O.P's occupation is unauthorized in all respect and the O.P's has failed to make out any case in support of his occupation.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Md. Alam & Anr. Qrs.No. 6, Block No. A, K.F. Shipping, P.S: S.P.P.S. Kolkata - 700 023 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Md. Alam & Anr. Qrs.No. 6, Block No. A, K.F. Shipping, P.S: S.P.P.S. Kolkata - 700 023 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

The matter is taken up today for delivering the final order. It is the case of **Syama Prasad Mookerjee Port, Kolkata** [earstwhile Kolkata Port Trust/ KoPT (hereinafter referred to as '**SMPK'**/ '**Port Authority**'), applicant herein, that Quarter No 6, Block No –A at K.F. Shipping Mazdoor Line, P.S. South Port Police Station, Kolkata- 700 023 was under lock and key of SMPK since 12.09.1994. However, one **Md. Alam** (hereinafter referred to as **O.P.**), rank outsider forcibly occupied said Quarter by breaking open SMPK's padlock on or about 16.06.1999 and since then O.P. was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by some other person, who is a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against the O.P. by issuing the Show Cause Notice dated 16.04.2021 (vide Order no 06 dated 15.03.2021) for adjudication of the prayer of eviction, under the relevant provisions of **Public Premises (Eviction of Unauthorized Occupants) Act, 1971** (hereinafter referred to as 'the Act') and the Rules made thereunder. The O.P. and any other person interested on the port property in question was called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intends to produce in support of their case.

The said Notice was sent through 'Speed Post' to the Quarter address of the O.P., and the notice did not return undelivered by the Postal Department raising the presumption of good service of the Notice upon the O.P. The 'Process Server' attached with this Forum has submitted his report dated 23.04.2021 intimating that the service of the notice could not be effected as the "party did not allow to enter the premises". the property under schedule, as per the mandate of the Act, as it appears from the said report of Process Server dated 23.04.2021. Inspite of such efforts made, the appearance of O.P. or any other person interested on the property under schedule could not be procured and the efforts remained futile. Following the principles of natural justice, further attempts were made to serve such notice in terms of Order dated 03.05.2021 and 26.07.2021. However, such efforts also went unsuccessful as it appears from the report of Process Server' dated 26.07.2021 that the party refused to receive the Order. However, on that occasion also the Notice was affixed on the property in question, in terms of the mandate of the Act.

Inspite of such efforts, nobody appeared before me with any authority to stay into the quarters in question. I have considered the report of the Process Server dated 23.04.2021 and 26.07.2021 regarding affixation of Show Cause Notice on the property in question. Hence, I am satisfied with the service of notice to all concerned. No reply to the Show Cause Notice u/s 4 of the Act dated 15.03.2021 on behalf of either O.P. or any other person has been filed. As such, I have nothing to disbelieve the statements made against the O.P. by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 1. That nothing has been shown in support of O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of O.P. as "authorized possession/occupation".
- 3. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.

4. That the O.P's occupation is unauthorized in all respect and the O.P's has failed to make out any case in support of his occupation.
