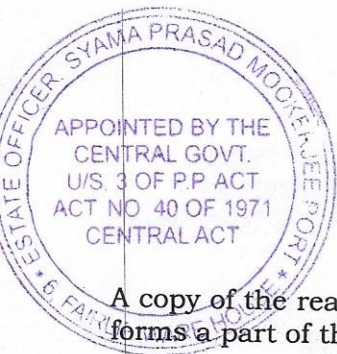
WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that

REASONS

Shipping Mazdoor Line, P.S.: S.P.P.S, Kolkata - 700 023 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said 1)Md. Kalim & 2) Sk.Sikander, both residing at Quarters No.2, Block No.G, K.F. Shipping Mazdoor Line, P.S.: S.P.P.S, Kolkata - 700 023 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

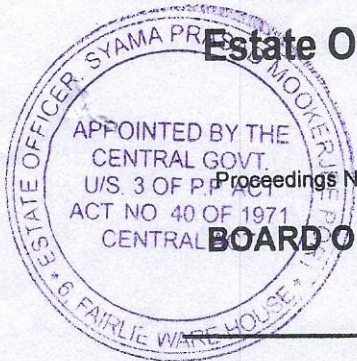

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 2 Bl. No. G at K.F. Shipping Mazdoor Line. The said quarter was under lock and key since 04.12.2000. On or about 17.05.2001, Md. Kalim, the Opposite Party, hereinafter referred to as O.P. 1 forcibly occupied the above quarters by breaking open the padlock. Since then O.P. 1 had been unauthorisedly occupying the said quarters without any authority. SMP,K vide application dated 06.04.2020 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by one Sk. Sikander, O.P. 2 herein another rank outsider.

SMPK filed application dated 09.08.2002 praying for an order of eviction against O.P. This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 22.02.2021. The said Show Cause notice along with the order dated 22.02.2021 were sent through "Speed Post", however the envelope has returned back with the Postal Remark "Insufficient Address". 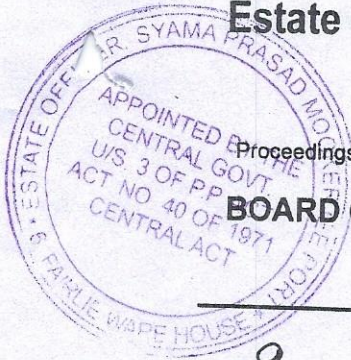

- (c) That no evidence has been laid to support the possession of O.P. No.1 & 2 as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.' No. 1 & 2's occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
