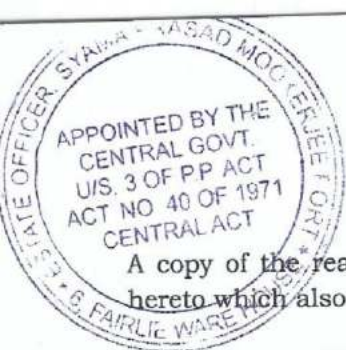

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that  
**Shri Ramesh, Quraters No. 12, Block No. 10 Hide Road Mazdoor Line,**  
**P.S.: S.P.P.S. Kolkata -700 043** is in unauthorized occupation of the Public  
Premises specified in the Schedule below:

**REASONS**

1. That nothing has been shown in support of O.P's occupation into the public premises.
2. That no evidence has been laid to support the possession of the O.P. as "authorized possession/occupation".
3. That mere occupation into the quarters for a period without any authority for such occupation cannot create any right over the property in question.
4. That the O.P's occupation is unauthorized in all respect and the O.P. has failed to make out any case in support of his occupation.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Shri Ramesh, Quarters No. 12, Block No. 10 Hide Road Mazdoor Line, P.S.: S.P.P.S. Kolkata -700 043 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Shri Ramesh, Quarters No. 12, Block No. 10 Hide Road Mazdoor Line, P.S.: S.P.P.S. Kolkata -700 043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

**FINAL ORDER**

The matter is taken up today for delivering the final order. It is the case of **Syama Prasad Mookerjee Port, Kolkata** [earstwhile **Kolkata Port Trust/ KoPT** (hereinafter referred to as '**SMPK**/' **Port Authority**), the applicant herein, that Qtrs. No. 12, Block No. 10 at Hide Road Mazdoor Line, was under lock and key since 18.05.2000 and one **Shri Ramesh**, the **Opposite Party/ O.P.** herein, forcibly occupied the quarter by breaking open SMPK's padlock on or about 16.10.2000 and since then, he has been living in the said quarter in an unauthorised manner. SMPK in terms of application dated 25.04.2022 has reported that during an inspection of said Quarter, it was found that the same has been under unauthorised occupation of one Smt. Munni Devi, who as per the said report is a "rank outsider" to the SMPK's Quarter.

Be it mentioned here that SMPK filed the application dated 07.12.2000, before this Forum of Law seeking, inter alia, an order of eviction against O.P. I am appalled by the fact that since then almost 22 years have been elapsed and it appears from records of the case that the matter was never placed before any Estate Officer, until it came up for adjudication before the undersigned. Needless to mention that such act has been against the basic spirit of the Public Premises Act, 1971, which provides for speedy machinery for disposal of cases.

Be that as it may, this Forum formed its opinion to proceed against the O.P. by issuing the Show Cause Notice dated 27.05.2022 (vide Order no 05 dated 27.04.2022) for adjudication of the prayer of eviction, under relevant provisions of **Public Premises (Eviction of Unauthorized Occupants) Act, 1971** (hereinafter referred to as '**the Act**') and the Rules made thereunder. The O.P. was called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized

representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P. intends to produce in support of his case.

The said Notice was sent through 'Speed Post' to the Quarter address of O.P. However, it was returned undelivered by the Postal Department with the remarks "addressee moved". The 'Process Server' attached with this Forum has submitted his report dated 06.06.2022, stating that the "party has refused to take the order". However, in terms of the said Report dated 06.06.2022, affixation of the notice was made on the property as per mandate of the Act.

It appears that neither the O.P. nor any person interested in the property has appeared before this Forum, on the scheduled date for filing the reply to show cause or even thereafter, till the passing of this Order. Nobody appeared before me with any authority to stay into the quarter in question till date. Considered the report of the Process Server dated 06.06.2022. I am satisfied with the service of notice to all concerned as affixation of Show Cause Notice u/s 4 of the Act was made on the property in question. It appears that no reply to the Show Cause Notice u/s 4 of the Act dated 27.05.2022, on behalf the O.P., has been filed. As such, I have nothing to disbelieve the statements made against the O.P. by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

1. That nothing has been shown in support of O.P's occupation into the public premises.
2. That no evidence has been laid to support the possession of the O.P. as "authorized possession/occupation".
3. That mere occupation into the quarters for a period without any authority for such occupation cannot create any right over the property in question.

4. That the O.P's occupation is unauthorized in all respect and the O.P. has failed to make out any case in support of his occupation.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s. 5 of the Act and Rules made thereunder against O.P., giving 15 days time to all to vacate the said Quarter/ public premises.

I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and Port Authority is entitled to claim damages for unauthorized use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
