WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that  
Shri Bijoy Singh, residing at Quarters No 9, Block No.48, Hide Road Mazdoor  
Line, P.S.: West Port Police Station, Kolkata-700043 is in unauthorized  
occupation of the Public Premises specified in the Schedule below :

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Shri Bijoy Singh, residing at Quarters No 9, Block No.48, Hide Road Mazdoor Line, P.S.: West Port Police Station, Kolkata-700043** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said **Shri Bijoy Singh, residing at Quarters No 9, Block No.48, Hide Road Mazdoor Line, P.S.: West Port Police Station, Kolkata-700043** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.



## FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarters No.9, Block No. 48 at Hide Road Mazdoor Line, P.S. West Port Police Station, Kolkata-700043 was under the lock and key of SMP, Kolkata since 03.04.2002. However, one **Shri Bijoy Singh(O.P.)** herein, forcibly occupied said Quarter by breaking open SMPK's padlock on or about 08.04.2002 and since then the O.P. was living unauthorisedly in the said quarter/public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one **Md. Salman** and another one **Giyasuddin**, who are rank outsiders into the quarter/public premises in question.

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction) dated 08.04.2022 (vide Order No.3 dated 07.04.2022) as per rule made under the Act and such Show Cause notice was sent to O.P both by hand and Speed Post as per address available on record. The Postal Service to the recorded address of O.P. returned undelivered to the Forum with a remark "addressee cannot be located" and the report of the Process Server dated 12.04.2022 depicts that such Notice was not personally served upon O.P. however, due affixation of such Show Cause Notice u/s 4 was made on the quarter in question. I am satisfied with service of notice to all concerned.

It is seen from the record that in the course of hearing nobody has appeared before the Forum to stay into the quarters in question. No reply to the Show Cause Notice has also been filed by the O.P or any person interested in the property as yet. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have nothing to disbelieve the statement made against O.P by the Port Authority. Accordingly the order of eviction issued on the following grounds/reasons:

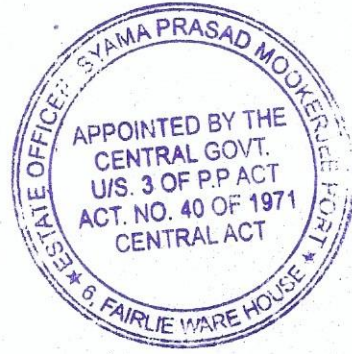

- 5) That O.Ps occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s 5 of the Act and Rules made thereunder against O.P, giving 15 days time to all to vacate the public premises. I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and SMP, Kolkata is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
