**ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that

S.P.P.S., Kolkata- 700 023** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 6 Bl. No. E at K.F. Shipping. The said quarter was under lock and key since 12.11.1999. On or about 05.03.200, Sri. Munna Lal, the Opposite Party, hereinafter referred to as O.P. No. 1 forcibly occupied the above quarters by breaking open the padlock. Since then O.P. No. 1 had been unauthorisedly occupying the said quarters without any authority. SMPK filed an application dated 23.03.2000 praying for an order of eviction against O.P. I am appalled by the fact that since then almost 22 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971. SMP,K vide application dated 04.01.2021 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by another rank Sri. Miraz Shah, hereinafter referred to as O.P. No. 2 and prayed for an order of eviction against O.P. No. 2.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 18.01.2021. The said Show Cause notice along with the order dated 18.01.2021 were sent through "Speed Post". The envelope was returned back with the remark "Insufficient Address". The Show Cause notice along with the order were also sent through Process Server. It is seen from the report of the Process Server dated 03.02.2021, that the order was duly received by Miraz Shah, the O.P. No. 2 herein. The said order dated 18.01.2021 was also affixed on a conspicuous part of the premises for notice to all concerned. As none appeared to represent the case of O.P.s inspite of of having knowledge of the pendency of

the proceedings, for the sake of natural justice, vide order dated 15.02.2021, another chance was given to O.P.s to file their reply to the show cause notice. The said order was sent through Process Server. It is seen from the report of the Process Server dated 01.04.2021, that the O.P. refused to take service of the order and did not even allow affixation of the order dated 15.02.2021 on the property. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P.s nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P.s or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P.s or anyone else
- (b) That nothing has been shown in support of O.P.s' occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P.s' as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.s' occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P.s, giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of
