WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri. Raju Bin, Qtrs. 4 Block No. 18 at Hide Road Mazdoor Line P.S. South Port Police Station. Kolkata- 700 023 is in unauthorized occupation of the Public Premises specified in the Schedule below:

#### REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.

#### FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP, K is the owner of the of Quarter No 4 Block no. 18 at Hide Road Mazdoor Line. The cause of action arose on 03.03.1998 and SMPK filed an application dated 08.01.1999 praying for an order of eviction against the Opposite Party hereinafter referred to as O.P. I am appalled by the fact that since then almost 21 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971. SMP,K vide application dated 08.02.2021 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by one Ashok Das.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 12.10.2022. The said Show Cause notice along with the order dated 12.10.2022 were sent through "Speed Post". The envelope, was however, returned with the remark by the Postal Department with

The order dated 26.10.2022 was also sent through Process Server attached to the Forum. It is seen from the report of the Process Server dated 03.11.2022, that the said order was received by one Nandini Das on 03.11.2022. It is further seen from the Report of the Process Server that due affixation of the order along with the Show Cause Notice dated 26.10.2022 was made on a conspicuous part of the premises for notice to all concerned. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place

their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P. or anyone else
- (b) That nothing has been shown in support of O.P.'s occupation into the premises;
- (c) That no evidence has been laid to support the of possession O.P. "authorised as possession/occupation"
- (d)That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order
