**ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Sri Vidya Sagore Pandey, residing at Quarters No.8, Block No.38, Hide Road, P.S.: W.P.P.S, Kolkata - 700 043, is in unauthorized occupation of the Public Premises specified in the Schedule below :

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P's occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as 'authorized possession/ occupation'.
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.

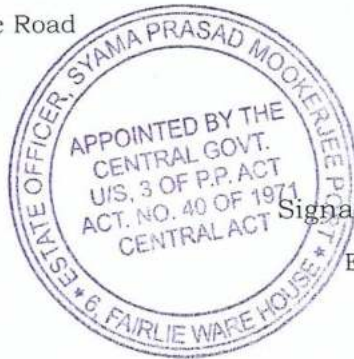

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 8 Bl. No. 38 at Hide Road. The said quarter was under lock and key since 03.08.1999. On or about 23.11.1999, Vidya Sagore Pandey, the Opposite Party, hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock. Since then O.P. had been unauthorisedly occupying the said quarters without any authority. SMP,K vide application dated 27.10.2022 submitted that on a recent inspection it was found that the subject quarter is still under the unauthorised occupancy of O.P.

SMPK filed application dated 31.01.2000 praying for an order of eviction against O.P. This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 22.01.2004. The matter was placed before me for hearing. On receipt of information, order dated 08.11.2022, was sent to O.P. calling upon him to appear before the Forum and file his reply to the show cause notice. Such order was sent

through Speed Post. However, the envelope has been returned by the Postal Department with the remark " No such person in the address".

It is seen from the report of the Process Server dated 20.12.2022, that O.P. refused to accept the order. However, due affixation was made on a conspicuous part of the public premises for notice to all concerned. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMPK before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P. or anyone else
- (b) That nothing has been shown in support of O.P. occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such


occupation cannot create any right over the property in question;

(e) That O.P. occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
