No 7, Block No.41, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata-700023 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Shri Tanbir Mollah & Janab Md. Nausad, residing at Qrs. No 7, Block No.41, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata-700023 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.Ps occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s 5 of the Act and Rules made thereunder against O.P, giving 15 days time to all to vacate the public premises. I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and SMP, Kolkata is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.

FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust/KoPT], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarters No.7, Block No. 41 at Hide Road Mazdoor Line, P.S. South Port Police Station, Kolkata-700023 was under the lock and key of SMP, Kolkata since 16.06.1997. However, one Shri Tanbir Mollah (O.P. herein), forcibly occupied said Quarter by breaking open SMPK's padlock on or about 29.06.2000 and since then the O.P. was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one Janab Md. Nausad, who is a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction) dated 18.08.2022 (vide Order No.6 dated 16.08.2022) as per rule made under the Act and such Show Cause notice was sent to O.P both by hand and Speed Post as per address available on record. Initially no one appeared on behalf of O.P or any other interested person to contest the instant matter however, on 29.09.2022 one Khurshid Alam, expressing himself as father of Janab Md. Nausad, appeared before the forum and prayed some time to vacate the quarter in question. However, on 10.11.2022 during the course of hearing no one appeared on behalf of O.P or any other interested party to contest the instant matter.

As no reply to the Show Cause Notice has been filed by the O.P or any person interested in the property as yet. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have nothing to disbelieve the statement made against O.F by the Port Authority. Accordingly the order of eviction issued on the following grounds/reasons:

1) That no reply to the Show Cause notice is filed by O.P.
