## **CORRIGENDUM TO**

NIT NO:- CT/01/2015-16/07 dated 06/04/2015.

REG:- Tender for repairing and renovation works at Ground Floor including Dining area & 1st Floor of Ko.P.T Guest House (excluding interior decoration works) at 93, Chowringhee Road.

a) Clause 6 of the Notice Inviting Tender [page 2/19 of the tender document] shall be read as:-

"The rate quoted by the tenderer should be complete in all respect and should include all duties, taxes, octroi, royalty, surcharge etc except Service Tax. Reimbursement of service tax will be made to the contractor by Ko.P.T on submission of actual payment of Service Tax at full rate for the work as per Finance Act, 1994."

b) Clause 18 of the "Special Conditions Of Contract" [page 8/19 of the tender document] shall be read as :-

"As Ko.P.T is not a Registered Body Corporate, it is not liable to pay service tax under 'Reverse Charge Mechanism' as per Service Tax Law. The service provider is liable to recover service tax as applicable. Reimbursement of service tax will be made to the contractor by Ko.P.T on submission of actual payment of Service Tax at full rate for the work as per Finance Act, 1994.

However, the Service tax will be deducted at applicable rate fixed by the government time to time on the amount of recoveries like L.D, damage, penalty, land rent, electricity charges etc. from the contractor's bill."

c) The following note shall be added at the last page of the "Bill Of Quantities" [page 15/19 of the tender document]:-

[Note:- The rate quoted shall include all taxes and duties as applicable excluding Service tax. Service Tax will be reimbursed by Ko.P.T on submission of actual payment of Service Tax at full rate for the work as per Finance Act 1994.]

The intending bidder shall be required to submit this Corrigendum duly signed alongwith his offer / tender.

All other terms and conditions of the tender shall remain unaltered.
