- (ii) Annexure-IV SL#: 5: The clause should be read as "Copy of valid Category / Class "A" Internet Service Provider (ISP) license / UASL (Unified Access Service License) issued from the Department of Telecommunication, Govt. of India".
- (iii) Annexure-II 2.Scope of Work: SL#:5: The clause should be read as "Internet Availability (uptime): Minimum 99.5% to be reviewed on a monthly basis".
- (iv) Annexure-II SLA Parameters: d) SL#:1 : The clause should be read as "Minimum requirement: 99.5% (Uptime Each month)".
