Minutes of the Pre-bid meeting held at 1200 hrs on 04.11.2016 in the room of Jt Director ( P&R ) in connection with the tender for supply, installation and commissioning of Desktop Computers, Laptops, Printer, scanner, UPS etc at Kolkata Dock System of Kolkata Port Trust.

The issues raised by various firms and also forwarded through e-mails were discussed in detail in the meeting and the decisions taken thereof are furnished below. The bidders are requested to submit their offer considering the decision taken in the pre-bid meeting and this will be part of tender document.

(i) Line Matrix Printers & Pass Book Printer :- It was informed that Line Matrix Printer and Pass Book printer of the following make/model would be acceptable :-

Line Matrix printer:

- (i) WEP Printronix P1000
- (ii) LIPI M 6810

Pass Book Printer:-

- (i) EPSON PLQ 20
- (iii) Lipi PB2
- 2. It was clarified that for the Gartner's Magic Quadrant (for Desktop PC & Laptop Compliance /Certification), top 4 manufacturers in the leaders quadrant will be acceptable in place of top 3.
- 3. It was also clarified and clearly mentioned that all equipments to be supplied under the subject tender should be IPv6 compliant. The bidders should submit their offer accordingly. Any deviation of the same would lead to rejection of the offer.
- 4. **Payment terms**: There will be no change in the payment terms as mentioned in the tender documents. However, efforts will be taken to make payment within 30-45 days from the date of submission of bills along with all necessary/required documents/ papers.

### 5. Laptop:-

- (i) Instead of Super Multi DVD writer, 8x DVD writer Internal to be supplied. External DVD writer will not be acceptable.
- (ii) Memory Minimum 4 GB DDR3 or higher expandable upto 16 GB in 2 DIMM slots of which 1 Free slot.
- (iii) Keyboard No separate numeric keypad required.
- (iv) Power Supply up to 65 watt EM AC power supply.

## 6. Desktop:-

- (i) Audio Internal Speakers in Monitor or CPU both are accepted.
- (ii) Memory Out of 287 Desktop PC, 17 Desktop PCs are to be supplied with 8GB RAM
  - i.e. 270 PCs with 4 GB RAM
  - & 17 PCs with 8 GB RAM
- 7. **Penalty** clause 9.0 Page 37 On request of the bidders, the matter was discussed in detail with other members present and it was decided that the maximum penalty to be imposed for a particular equipment will be limited to the price of the particular equipment. There will be no change in the rate of penalty.
