#### TERMS AND CONDITIONS OF TENDER FOR PROCUREMENT OF 01 NO. AMBULANCE

#### 1. PRE-QUALIFICATION CRITERIA OF THE BIDDERS:-

- 1.1 Copy of GST Registration certificate should be submitted.
- 1.2 Bidders have to deposit a sum of ₹ 5,000.00 as an earnest Money. The earnest Money Deposit shall have to be deposited by Demand Draft of any Nationalized / Scheduled Bank of India drawn in favour of " Syama Prasad Mookerjee Port, Kolkata, Haldia Dock Complex " payable at Haldia by you. Earnest money would be refunded after satisfactory completion and delivery of the work.
- 2. Mere participation in tender will not mean that a particular bidder will automatically be considered qualified and their bids will be entertained. Such qualification will be reviewed at the time of evaluation of bids also.
- 3. The trustees reserve the right to reject or to accept the tender in whole or in part without assigning any reason whatsoever thereof.

#### 4. Scope of Work:

The work comprises of supply of 01 no. Ambulance with registration at least for a period of 03 months, Road Tax, 06-month pollution test & at least one-year insurance coverage. The vehicle has to be delivered at site of Haldia Dock Complex after registration etc. Registration of the vehicle would be done in the name of Egra We Care at Egra.

#### 5. **Validity**:

The tender shall remain open for acceptance for a period of 120 days from the date of opening of techno-commercial bid.

#### 6. Prices:

Price of 01 no. Ambulance with accessories, minimum 01 year insurance, Registration at least for a period of 03 months, Road tax, 06 month pollution test etc should be completed in all respect and should be quoted on F.O.R. site/store of Haldia Dock Complex i.e. free delivery basis. The Bidder shall state clearly the percentage of various GST and other charges if applicable extra over his quoted rates.

Price shall remain firm till the goods are delivered and no price escalation shall be allowed.

#### 7. **Evaluation:**

Evaluation will be made on L1 offer on turn key basis (i.e. cost of ambulance including Registration charges at least for a period of 03 months, road tax charges, minimum one year insurance charges, 06 Month pollution test charges) on F.O.R. site/store of Haldia Dock Complex.

#### 8. Payment:

Payment will be made after receipt of vehicle in all complete manner & in all respect on turn key basis at the site/store of Haldia Dock Complex against supplier's clear bill within 30 (Thirty) days of receipt of clear bill along with Registration at least for a period of 03 months, road tax, one-year insurance, 06 Months pollution test, etc. Payments shall be credited to supplier's bank account through ECS/NEFT/RTGS mechanism at all centers where such facilities are available in the bank. Accordingly, bidders are requested to submit their bank Account Number with the name and address of the bank along with the branch name and code number in the bill.

## 9. **Delivery**:

Vehicle complete in all respect on turn key basis to be delivered along with Registration at least for a period of 03 months, road tax, minimum one-year insurance, 06 Month pollution test, etc within 30 days from the date of receipt of order at the site/store of Haldia Dock Complex. 01 no. Ambulance would be accepted based on guarantee certificate, and other documents such as Registration certificate at least for a period of 03 months, Road Tax, 06 Month pollution test & minimum one-year insurance certificates etc. Also, manuals and tools as stated in the Annexure-B of the tender.

#### Vehicle (01 No. Ambulance) Registration: 10. Ambulance need to be registered as per the applicable Motor Vehicle Act. Registration should be done in the name of Egra We Care at Egra. All the charges for registration would be borne by the successful bidder. Registration shall be at least for a period of 03 months. 11. Packing Of Materials: The Supplier shall be responsible for proper packing and delivery of Stores. The materials should be packed by the Supplier/Manufacturer at their own cost and arrangement for protection against any damage, loss, breakage or leakage etc. 12. **Jurisdiction Of Court:** The contract shall be governed by all relevant Indian Acts applicable within the jurisdiction of High Court at Calcutta. 13. **Technical Specification:** Full particulars as to specification, name of manufacturer of motor van/ vehicle and model number etc should be stated clearly, failing which the tender shall not be considered for Guarantee: 14. The vehicles (as per tender BOQ) to be supplied must be guaranteed against manufacturing defect at least for a period of 12 months from the date of acceptance of the material at the site/store of Haldia Dock Complex. If any manufacturing defect, whatsoever, develops during this guarantee period, the same will have to be rectified / replaced (as the case may be) by the supplier at his / their own cost and arrangement. Guarantee Certificate is to be furnished by the supplier at the time of supplying the material to store. 15. **Free Services Support:** Supplier will have to ensure and clearly indicate the number of free services on its 01 no. Ambulance so that Egra We Care / Haldia Dock Complex may avail these services within the stipulated conditions of time period or km range, whichever is earlier from the date of purchase. 16. Workmen Compensation: The successful bidder(s) must cover his employees / workers, who will be engaged for delivery, unloading & stacking job at HDC's site, under workmen compensation act, fatal accident act and personal injuries insurance act for protection against any injury / accident and shall have to bear all the consequences and cost as applicable as per relevant acts. 17. Personal Protective Equipment (PPE): Suppliers and their workmen including driver & helper must use PPE i.e. Safety Helmet etc. at the time of supply of materials inside the dock premises.
