#### 5.7 <u>DETAILED SCRUTINY OF E-TENDERERS:</u>

# 26 **DELIVERY**:

The entire contractual obligations are to be completed in all respect within 90 days from the date of issuance of LOI/LOA or Work Order, whichever is earlier.

Materials shall be delivered by the supplier to HDC's Coal Handling Plant site/store at Haldia at their cost, risk and responsibility. Delivery period shall be binding on the supplier. If delivery of materials is not made within the time undertaken without sufficient reasons acceptable to the Board, the order may be cancelled without notice at the option of Board. In the event of failure to execute the order, Board will take penal action against the supplier and his name will be removed from the list of approved suppliers. In case of default in supply or, failure to deliver as per correct specification or, the approved quality within the time stipulated by Board are entitled to purchase the Items from any other source at the risks, costs and expenses of the supplier. Such purchase may comprise the whole or, any portion of the supply remaining undelivered or, not approved. The successful Bidder must make their own arrangements for delivery of all materials, as well as for careful and proper unloading and stacking at HDC's Store/Site. The responsibility for preventing damage / deterioration to the materials during transit, delivery, unloading and stacking at the designated point shall rest with the Supplier. All transit risk will be to supplier's account. The Bidder must send advance

intimation to the concerned Officer as to the proposed dates of delivery of each and every installment of supply together with a list showing quantity and particulars of the material in the consignment. Materials will not be accepted if not accompanied by the authorized representative along with proper Delivery Challan, Inspection/Test Certificate, Guarantee Certificate and other related documents. Delivery of materials will not be accepted on Sundays and Holidays. No lorry shall be permitted into the protected area during night-time. Detention of lorries, if any, will be on supplier's account. The authorized representative of the Bidder should be present at the time of delivery.

# 27 PACKING:

Suppliers shall be responsible for proper packing and delivery of materials in good condition. Materials shall be packed in proper way by the supplier at his own cost and arrangement for protection against damage, loss, leakage, breakage etc.

# 28 **DESPATCH ARRANGEMENTS:**

The supplier shall be fully responsible for any transit loss or damage to the materials. In case **e-way bill** is required to deliver the materials, suppliers need to arrange themselves for the same through latest online portal.

# 29 TRANSIT RISK:

Transit risk will be on supplier's account since the delivery is to be made on F.O.R. Destination basis.

#### 30 **RISK PURCHASE:**

In case of supplier's failure and at the absolute discretion of the Sr. Dy. Manager (P&E), the work may be ordered to be completed by some other agency at the risk and expense of the supplier (successful tenderer) after a minimum three days' notice in writing has been given to the supplier by the Sr. Dy. Manager (P&E) or, his representative. In case of risk purchase extra cost will be borne by the supplier (successful tenderer).

# 31 **DOCK PERMITS**:

The successful Bidder shall have to obtain permits from the office of the Sr. Dy. Manager(P&E) or his authorised representative for delivery of materials and Dock Permit or as directed for entry of their vehicles and workers into the Board' Stores for unloading and stacking of the material. Such permits shall be issued to the Bidder against receipt of proper application with **payment of necessary charges** (if any) for the same during normal working hours on any working day.

# 32 **REJECTION OF MATERIALS:**

Notwithstanding the inspection and passing of materials by Board' authorized person (representative of P&E Division), any material found to be defective in quality and not conforming to the relevant specification, shall liable to be rejected and the supplier shall replace the same at his cost and arrangement at the earliest. The supplier shall at his own arrangement and cost replace within a period of 1 (one) month all such dispatched materials that have either been rejected by Board' authorized person (representative of Sr. Dy. Manager-P&E), or have been found in defective/broken/damaged condition after unloading. Rejected materials shall be at Supplier's risk. They must be collected from the Board' Stores, H.D.C. within a fortnight from the date of rejection on observing usual procedure on the matter. If the contractor fails to remove such materials within a reasonable time, the Board shall

have the right to dispose of the same and the supplier shall have no claim against the Board in respect of the said rejected materials.

# 33 **LIQUIDATED DAMAGES:**

If the successful bidder (supplier) failed to supply materials during the delivery period, LD will be levied @ ½% per week on the value of the delayed portion subject to maximum of 10% of total basic value of order and

GST would be chargeable extra on LD as applicable.

# 34 BANNED OR DE – LISTED CONTRACTORS:

Bidders must give a declaration to the effect that they have not been banned or, de-listed by any Government or, quasi – Government agency or, PSU. If a bidder has been banned / de-listed by any Government or, quasi – Govt. agency or, a PSU, the details of any such ban must be clearly stated along with the relevant documents which the Bidder is to enclose together with the Techno- Commercial Bid. Incorrect declaration or, suppression of facts will lead to rejection of the Offer.

#### 35 **FORCE MAJEURE:**

In the event of either party being rendered unable by Force Majeure to perform any obligations required to be performed by them under the contract, the relative obligation of the party affected by such Force Majeure shall, upon notification to the other party, be suspended for the period during which such Force Majeure event lasts. The cost and loss sustained by either party shall be borne by the respective parties. The term 'FORCE MAJEURE', as employed herein, shall mean acts of God, Earthquake, Tsunami (caused by earthquake at the ocean bed), War, Revolt, Riot, Fire, Floods, Sabotage and Hurricane/Cyclone, Strike {excluding that of the contractor's supplier(s) or the sub-contractor's employees}. Upon the occurrence of such case and upon its termination, the party alleging that it has been rendered unable, as aforesaid, shall notify the other party in writing immediately, but not later than 48 (forty-eight) hours of the alleged beginning and ending thereof, giving full particulars and satisfactory evidence in support of its claim.

# 36 JURISDICTION OF COURT:

The contract shall be governed by all relevant Indian Acts applicable within the jurisdiction of High Court at Kolkata.

# 37 WORKMEN COMPENSATION:

The successful bidder(s) must cover his employees / workers, who will be engaged for delivery, unloading & stacking job at SMPK's site, under workmen compensation act, fatal accident act and personal injuries insurance act for protection against any injury / accident and shall have to bear all the consequences and cost as applicable as per relevant acts.

#### 38 GUARANTEE PERIOD

The materials, with all accessories and attachments, shall have to be guaranteed by the supplier against the manufacturing defects or, poor performance for a period of 12 months from the date of commissioning or, 18 months from the date of delivery & acceptance, whichever is earlier. If any defect whatsoever develops during the Guarantee Period, the defective materials will have to be replaced/rectified, as the case may be, by the Bidder at their own cost.

#### 39 CERTIFICATES:

- 1. Guarantee Certificate of the supplier is to be submitted at the time supply of materials.
- 2. Manufacturer's Test Certificate(s) or from certificate from authorized Govt Test laboratory House, must be produced at the time of inspection of materials and the same shall be supplied along with supply.

#### 40 PERSONAL PROTECTIVE EQUIPMENT(PPE):

Suppliers and their workmen including driver & helper must use PPE i.e. safety helmet etc. at the time of supply of materials inside the dock premises.

# 41 **DEFAULT CRITERIA**:

HDC may serve a written notice of default to the Supplier in case of following situations

- i) If supplier fails to deliver any or all of the materials within the Time period(s) specified in the contract or any extension thereof granted by HDC.
- ii) Delivery is unsatisfactory as per Tender Terms.
- iii) If supplier fails/delays to perform any other obligation(s) under the Contract.
- iv) In either of the above circumstances, does not remedy his failure within a period as specified in contractor such period as HDC may authorize in writing after serving default notice to the supplier.

# 42 GENERAL CONDITIONS OF CONTRACT:
