Annexure-A

Terms & Conditions.

- 1. <u>Price:</u> The prices, to be quoted should be based on the above F.O.R. door delivery at Coal Handling Plant. The prices should be indicated in the **Bill of Quantities (Annexure B**, enclosed) only. The prices excluding GST and other statutory Taxes & Duties, if any, shall be firm and fixed till completion of the aforesaid work.
- 2. <u>Taxes & Duties:</u> The particulars of GST and other statutory Taxes & Duties, if any, as applicable, are to be furnished clearly in the offer.
 - If any New Tax & Duties increase in rate of Tax & Duties is imposed / effected by Central / State Government, which will be applicable to this Contract, Trustees will consider reimbursement of payment made against such Taxes, Duties against documentary evidence of such payment made. If there is downward revision in any of these taxes, Duties or abolition of any of these, you shall give due rebate on such of the rates, as would be effected by such revision or abolition.
- 3. Payment Terms: 100% payment will be made within 30 (thirty) days from the date of delivery at the HDC's Site Store at Coal handling Plant and acceptance of the same by the authorized representative of Sr. Dy. Manager (P&E) or Dy. Manager (P&E), CHP, after submission of clear and unambiguous bills, whichever is later. The bill should be accompanied with inspection report, fitment certificate and guarantee certificate.
- 4. <u>Completion Period:</u> Total job is to be completed within **60 (Sixty)** days from the date of issue of work order.
- 5. <u>Guarantee:</u> You have to provide guarantee of materials for 12 (twelve) months from the date of commissioning or 18 (eighteen) months from date of supply which is earlier.
- 6. <u>Inspection:</u> Visual inspection of materials shall be carried out by the representative of Sr. Dy. Manager (P&E) or Dy. Manager (P&E), CHP, at HDC's site, based on your Fitment Certificate and Guarantee certificate.
- 7. <u>Validity:</u> The validity of your offer should not be **less than 60** (sixty) **days** from the date of opening of offer.
- 8. **EVALUATION CRITERIA:** While the rate quoted by the bidders against the complete work as mentioned in the BOQ, will be taken into account and **selection will be made on the basis of total lowest price** against the said items.
- 9. <u>Liquidated Damage Clause:</u> In the event of your failure to execute the contract within the stipulated dates or such extension(s) thereof, as may be allowed by the Sr. Dy. Manager (P&E) in writing, you will be required to pay as compensation to the Trustees and not as penalty @ ½ % of total contract value for every week or part thereof, provided always the entire amount of compensation to be paid under the provision of this clause shall not exceed 10% of the total contract value. The Trustees may, without prejudice to any other method of recovery, deduct the amount of such damages from any money which is due or which may become due to you. The payment or deduction of such damages shall not relieve you from your obligation to complete the supply of material or from any other of your obligation or liabilities under the contract.

10. <u>Gate Pass:</u> Photo permit / Gate Pass (RFID based) will be issued on chargeable basis, as per rules of HDC. The following documents will be considered as a valid proof of identity.

- Pass port (Relevant pages with photo & address)
- Driving License.
- Voter ID Card (EPIC).
- AADHAAR (UID).
- Income Tax PAN Card.

Please note that document substantiating proof of identity is required to be submitted once for each individual. For getting subsequent permits, the sponsoring firms may quote ID number and type of ID of the individual which was submitted initially for registration.
