"Tenderer should have experience in completing up keeping & General maintenance of building /sheds etc or similar works like deploying of labours for different works during last 7 years ending at the last day of the month previous to the one in which applications are invited which should be either of the following:

- 01. (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated value.
 - (b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.
 - (c) One similar completed works each costing not less than the amount equal to 80% of the estimated value.
- 02. (a) All intending tenderer (at the time of tendering) shall disclose all necessary documents as to whether they are covered under ESI Act or not at the time of tendering
 - (b) In case they are covered under ESI Act, they have to furnish the details of registration No. failing of which the tender would be liable to be cancelled.
 - (c) In case they are not covered under ESI Act or exempted, they would furnish necessary documents along with an affidavit affirmed before a first class Judicial Magistrate on Non-Judicial Stamp paper of Rs. 10.00 as per enclosed proforma in ANNEXURE-"B" to that effect.
 - (d) In case they are not covered under ESI Act, they must additionally indemnify KoPT against all damages and accident occurring to his labour in non-judicial stamp-paper worth Rs. 50.00 in the enclosed format ANNEXURE-"A".
- 3. The Average Annual Financial turn over of the intending Tenderer during the last 03 (three) years ending 31^{ST} March of the previous financial Year should be at least 30% of the estimated amount put to tender.
- 4. In the tender documents, the attached checklist should be duly filled up by the Tenderers putting their signature in the requisite place and enclosing the relevant papers along with the tender documents. If the Tenderer fails to submit such check list duly filled up the tender would not be considered for opening the same. If contents of the checklist as furnished by the bidder turns out to be malpresentation of facts,

then such bids would be rejected even after opening the price bid with a recorded warning for the bidder. A Proforma of checklist is enclosed (Annexure -C) for attaching in tender documents

5. Tenderers are required to furnish relevant documentary evidence in original of the above ,if necessary. In case of any non-conformity of the same, the concerned tender would be liable to be rejected.

- 2. The Trustees' General Conditions of Contract for the said tender (rest of the documents like Special Conditions of Contract, Technical Specifications, Bill of Quantities etc. are attached herewith) may be inspected at this office during office hours.
- 3. The tenderers, who are tendering beyond their financial limit as per their class of enlistment with KoPT, as per New Rules, are requested to deposit with KoPT's Financial Advisor & Chief Accounts Officer a sum of Rs. 8.750/-
- as Earnest Money before submission of the tender. The original receipt must be attached with the tender without which the tender may be disqualified. This amount will be refunded to the unsuccessful tenderers without any interest. In case of being successful tenderer, this amount will be adjusted against the Security Deposit as per the relevant clause of the G.C.C.
- 4. The rates quoted by the Contractor must be valid upto 120 days from the date of opening of the tender.
- 5. The rate quoted by the tenderer should be complete in all respect and should include all taxes, octroi, surcharge etc. and no extra payment, whatsoever will be entertained by the Trustees under any circumstances.
- 6. While quoting the rate it should be noted that the tenderer should on no account overwrite the figures. Any necessary correction should be made by cancelling the original figures and writing the corrected figures on the top. All such corrections should be initialled by the tenderer. If the figures are tampered with, the tender shall be rejected.
- 7. If there is any disparity between the quoted rate in percentage and the Tender Amount, the rate quoted in percentage shall prevail as the rate quoted by the tenderer and the Tender Amount shall be derived by adding/substracting (as the case may be) this percentage with/from the Estimated Value put to tender. Similarly in case of disparity between the rate quoted in figures and in words, the rate quoted in words shall prevail.

SPECIAL CONDITION

- 1. Contractors eligibility for participation in the tender:
- "Tenderer should have experience in completing up-keeping & General maintenance of building /sheds etc or similar works like deploying of labours for different works during last 7 years ending at the last day of the month previous to the one in which applications are invited which should be either of the following:
- (A). (i) Three similar completed works each costing not less than the amount equal to 40% of the estimated value.
 - (ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.
 - (iii) One similar completed works each costing not less than the amount equal to 80% of the estimated value.
- (B). (i) All intending tenderer at the time of tender shall disclose all necessary documents as to whether they are covered under ESI Act or not.
 - (ii) In case they are covered under ESI Act, they have to furnish the details of registration, failing which their tender would be liable to be cancelled.
 - (iii) In case they are not covered under ESI Act or exempted, they would furnish necessary documents along with an affidavit affirmed before a first class Judicial Magistrate on Non-Judicial Stamp paper of Rs. 10.00 as per enclosed proforma in ANNEXURE-"B" to that effect
 - (iv) In case they are not covered under ESI Act, they must additionally indemnify KoPT against all damages and accident occurring to his labour in non-judicial stamp-paper worth Rs. 50.00 in the enclosed format ANNEXURE-"A".
 - (C) All tenderer should enclose a checklist duly filled up enclosing the relevant documents as per the Proforma attached with tender documents. If the tenderer fails to submit such checklist duly filled up, the tender would not be considered for opening. If contents for the checklist turns out to be misrepresentation of facts, then such bids would be rejected even after opening of price bid with a recorded warning for the bidder. A Proforma of checklist is enclosed (Annexure C) for attaching in tender documents.
 - D) The successful tenderer will be required to comply with the relevant provisions of Building and other construction workers (Regulation of Employment and Conditions of Service) Act, 1996 and West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 2004 as well as Building and Other Construction Workers' Welfare Cess Act, 1996 and rules framed there under.

(E) Tenderers are required to enclose all relevant documentary evidence duly certified to above stated in the above regard during submission of the tender. In case of any non-conformity to the same, the concerned tenders would be liable to be rejected".

2. Scope of work

Base Camp at <u>Nischintapur</u> comprising of 5 (five) nos. shed / blocks having 25 nos. of room which are used as stores, office rooms etc., . There is 2800 Sqm (approx) of open yard in the camp premises. Base Camp at <u>Phalta</u> comprising of 5 (five) nos. shed / block having 29 No rooms, which are used as, stores, office rooms etc.. There is 3000 Sqm (approx) of open yard in the camp premises. Base Camp at <u>Swarupganj</u> comprising of 5 (five) nos. shed / blocks having 20 nos. of room which are used as stores, office rooms etc.,. There is 3000 Sqm (approx) of open yard in the camp premises. The successful tenderer will have to carry out up-keeping and regular maintenance of the said Office Buildings and camp premises, supplying appliances including consumable materials & other ancillary services as and when required as per Bill of Quantities and as directed by the Engineer-in-Charge or his representative.

3. Location of work:

The Base Camps are located at Nischintapur (Dist. South 24 Pgs) at about 80 km from Kolkata, at Phalta (Dist. South 24 Pgs) at about 45 km from Kolkata & at Swarupganj (Dist. Nadia) at about 120 km from Kolkata under River Training Wing of Civil Engineering Department,

4. <u>Method of measurement and payment.</u>

As per relevant B.O.Q Items.

On-account payment may be arranged in terms of Clause No. 6.0 of the General Conditions of Contract & as per discretion of the Engineer.

5. Escalation of price.

No escalation on account of variation in the prices of labour shall be admissible during the pendency of the subject work.

6. Time of completion.

Though the tenure for the said work is for one year from the date of placement of work order, the Contract may be closed earlier at the sole discretion of the Engineer with one-month notice to the Contractor. If necessary and under circumstances, the Engineer shall have to right to extend the period of the contract beyond the stipulated Contract period under mutual consent of the successful tenderer for which no extra payment shall be made to the Contractor.

7. <u>Discrepancies in contract documents.</u>

In case of any discrepancies in the tender, the relevant Clause of General Conditions of Contract shall apply and the decision of the Engineer-in-Charge is final and binding on the tenderer regarding interpretation of any Clauses.

8. Employment of Local Resources.

The tenderer shall pay special attention to engage the maximum possible number of Engineers, other technical personnel, other workers and labourers from amongst the local people.

9. Labour Regulation & Abolition Act.

The Contractor shall be required to comply with the Minimum Wages Act 1948, Employees Liability Act 1938, Industrial Act 1947 and the Contract Labour (Regulation & Abolition) Act 1970 or statutory amendment and the modification thereof or any other laws relating thereto and the rules made there under from time to time.

It will be the duty of the Contractor abide by the provisions of the Acts, Ordinances, Rules, Bye-laws, Procedures as are lawfully necessary in the execution of the works. The Contractor will be fully responsible for any delay, damage etc. and shall keep the Trustees' Engineer Indemnified against all penalties and liabilities of any kind for non-compliance or infringement of any such Acts, Ordinances, Rules, Regulations, Bye-laws and Procedures.

The Contractor shall indemnify the Trustees against payment to be made under or for the observance of the laws aforesaid without prejudice to his right to claim indemnity from his business associates.

10. Protection of existing service.

The work sites are within the campus of the existing Office-cum-Residential complex. The existing work facilities and service shall be duly protected by the contractor. Any damage to the existing structure or service done in the process of work shall be made good at the cost of the contractor immediately on intimation from the Engineer-in-Charge.

11. As KOPT is not a Registered Body Corporate, it is not liable to Pay service tax under "Reverse Charge Mechanism" as per Service Tax Low. The service provider is liable to recover service tax as applicable"

- 12. All intending Tenderers shall have furnish detail of E.P.F. Registration failing which their tender would be liable to be cancelled
- 13. All intending tenderer shall have to furnish the details of Trade License.
