Prequalification Criteria:

- 1. a) Tenderer should have experience in *constructing fencing* or any other civil engineering construction/ maintenance works and have successfully completed similar* works during last 7[seven] years ending last day of month previous to the one in which applications are invited should be either of the following:
 - i) Three similar* completed works each costing not less than the amount equal to 40% of the estimated amount put to tender.
 - ii) Two similar* completed works each costing not less than the amount equal to 50% of the estimated amount put to tender.
 - iii) One similar* completed work costing not less than the amount equal to 80% of the estimated amount put to tender.
 - * Similar works means constructing fencing or any other Civil Engineering construction/ maintenance works. Completed means completed satisfactorily.
 - b) The average Annual Financial turnover of the intending tenderer during the last **3** years ending 31st March of the previous financial year should be at least 30% of the estimated amount put to tender.
 - c) Work experience, as a sub-contractor or a supply (material) contractor shall not be considered as the requisite qualification.
- **2.** The Trustees' General Conditions of contract and Schedules of rates may be inspected at this office during office hour. Rest of the documents like special conditions of contract, B.O.Q. etc. are attached herewith.
- **3.** In case of a tenderer who has already deposited a permanent security with the KoPT under the new rules, he shall be bound by the clauses of the General Conditions of the Contract pertaining to earnest money and security deposits for registered contractors.
- **4.** The tenderers, who are tendering beyond their financial limit as per their class of enlistment with KoPT, as per New Rules, are requested to deposit a sum of **Rs. 6,150.00** as Earnest Money in the from of Bankers' cheque/ Demand Draft/ Pay order in favour of "**KOLKATA PORT TRUST**" on any Scheduled Bank payable at Kolkata before submission of the tender. If the tenderer submits Demand Draft, Banker's Cheque or Treasury Receipt against earnest money at a date prior to the publication of the NIT, the same cannot be accepted. The original Bankers' cheque/ Demand Draft/ Pay order must be attached with the tender without which the tender may be disqualified. This amount will be refunded to the unsuccessful tenderer(s) without any interest. In case of being the successful tenderer, this amount will be adjusted against the Security Deposit as per the relevant clause of the G.C.C.

- 5. It is impressed upon the tenderer that his tender should be based on the conditions stipulated in the tender document and that the tenderer should not stipulate his own condition in deviation thereof, as apart from the likelihood of vitiating the tender, such deviations will lead to non-uniformity of tenders and it will be difficult to make assessment of the correct value of the tenders for purposes of comparison. In such event tender may be considered incomplete and may be rejected.
- **6.** The Tenderer shall include in their prices any sum payable as Taxes, particularly VAT, Octroi, Royalty, Surcharge etc. to the Government or Public Bodies or Individuals and such taxes shall not be an extra charge payable by the Trustees'.
- **7.** "As KoPT is not a Registered Body Corporate, it is not liable to pay service tax under 'Reverse Charge Mechanism' as per Service Tax Law. The service provider is liable to recover service tax as applicable. Reimbursement of service tax will be made to the contractor by KoPT on submission of actual payment of Service Tax at full rate for the work as per Finance Act, 1994"

However the contractor is liable to pay the Service tax element at applicable Govt. rate fixed by the government time to time against LD, damage penalty, land rent, electricity charges etc. same will be deducted from his bill when sent to finance department for payment.

In the event of item(s) bought with Cenvat, if any, the contractor is required to ensure that invoices are drawn in the name of contractor and it should be marked "account KOLKATA PORT TRUST" as per cenvat credit rules and regulations. KoPT would provide the Service Tax Registration No. for availing Cenvat Credit.

As far as possible items are to be procured from first/ second stage dealer and the contractor is to maintain the above formalities to the extent possible so that KoPT can avail the cenvat credit.

However payment to the contractor for work will be made as per provision in Item – 6 of Preamble to the Bill of Quantities of Price Bid.

- **8.** a) All intending Tenderer at the time of tender shall disclose all necessary documents as to whether they are covered under ESI Act or not.
 - b) In case they are covered under ESI Act they have to furnish the details of registration, failing which their tender would be liable to be cancelled.
 - c) In case they are not covered under ESI Act or exempted, they would furnish necessary documents along with an affidavit in original affirmed before a first class Judicial Magistrate in a Non-Judicial Stamp Paper worth Rs. 10.00 to that effect as per enclosed KoPT approved format. (Format of affidavit is enclosed at the end of the tender as **Annexure marked A)**.

Regarding submission of Affidavit, the stamp paper should be either in the name of the tenderer or with name of the Advocate who has signed in the Affidavit. The bidder may purchase stamp-paper prior to the publication of tender but the Affidavit must be sworn after the date of hoisting/ publication of NIT.

- d) In case they are not covered under ESI act they must additionally indemnify KoPT against all damages & accident occurring to his labourer in a non-judicial stamp paper worth Rs. 50.00. The same should be submitted by the L–1 tenderer after opening of the tender. The Format of indemnity Bond may be inspected at the office of the Sr. Ex. Engineer, Railway.
- e) All intending tenderers shall furnish details of EPF registration failing which their tender would be liable to be cancelled.
- f) The intending tenderer shall have to submit the copy of the valid trade licence.
- **9.** The tenderer shall submit certified copy of the Certificates of VAT Registration No. and also declare their Permanent Income Tax Account No. in the last page of the B.O.Q.
- **10.** Tender documents shall be issued from the Senior Executive Engineer, Railway's office at 51, C.G.R. Road Kolkata 43. The tenderer shall have to deposit with the Trustees' Financial Adviser & Chief Accounts Officer at 15, Strand Road, Kolkata-700 001 a sum of Rs. 300.00 [Non-refundable] towards cost of Tender documents.
- 11. Tenderers may also submit the tender getting downloaded from the Web site of Kolkata Port Trust www.kolkataporttrust.gov.in. In that case, the intending tenderer shall have to pay the amount of Rs.300.00 [Non-refundable] towards the cost of bid document by draft or Bankers' Cheque drawn in favour of "KOLKATA PORT TRUST" at the time of submission of tender documents.

- **12.** The tenders duly filled in, totalled and signed along with the following documents and others shall be submitted in a sealed cover superscribed the above name of work so as to reach this office within 3pm on 14.10.2015. The submitted tenders will be opened shortly after 3pm, on the same day and the intending tenderers or their authorised representatives may attend. In the event of any unforeseen circumstances such as holidays, bandhs, strikes etc. on that day, the tenders may be submitted by 3pm on the next working day, and will be opened shortly after 3pm on the same day. All other conditions shall remain the same.
- Copy of the documents in support of prequalification criteria as mentioned in clause No. 1 above.
- b) Copy of Vat Registration Certificate.
- c) Copy of ESI Registration Certificate or copy of documents as mentioned in clause No. 11 above.
- d) Copy of PAN Card.
- **13.** While quoting the rate it should be noted that the tenderer should on no account overwrite the figures. Any correction, necessary, should be made by cancelling the original figures and writing the corrected figures on the top. All such corrections should be initialled by the tenderer. If the figures are tampered with, the tender shall be liable to be rejected.
- **14.** If there is any disparity between the quoted rate in percentage and the tender amount, the rate quoted in percentage shall prevail as the rate quoted by the tenderer and the tender amount shall be derived by adding/subtracting (as the case may be) this percentage with/ from the estimated value put to tender. Similarly in case of disparity between the rate quoted in figures and in words, the rate quoted in words shall prevail.
- **15.** All tenderers should enclose a check list duly filled up enclosing the relevant documents as per the proforma attached (**Annexure marked B**) with the tender documents. If the tenderer fails to submit such check list duly filled up, the tender would not be considered for opening. If contents of check list turn out to be misrepresentation of facts, then such bids would be rejected even after opening of price bid with a recorded warning for the bidder.

The check list should be attached as a covering letter along with the sealed envelope containing the offer.

- **16.** The undersigned does not bind himself to accept the lowest or any tender or to assign any reason therefore and also reserve the right to accept or reject any or all the tenders in part or whole.
- **17.** If the offers are not received according to the instructions detailed hereinabove, they shall be liable for rejection. The corrections and remarks shall be either type-written or must be in ink and duly authenticated
- **18.** Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have made misleading or false representations in the forms, statements and attachments submitted as proof of the prequalification requirements and their EMD will be forfeited for such action.

NAME OF WORK

Constructing fencing around Taratala Overhead Tank & blocking entrance of 47 nos building at Taratala Colony.

SCOPE OF WORK

The work comprises for Construction of fencing around the overhead tank as well as blocking entrances of 47 No. buildings all inside Taratala compound under Railways division jurisdiction as set forth in the Bill of Quantities including any other appurtenant work as may be required for successful completion of the work as may be directed by the Engineer or his representative at site.

SPECAL CONDITIONS OF CONTRACT

General: These conditions are part of the tender documents, which must be read as a
whole, the various sections being complimentary to one another and are to be taken as mutually
explanatory. These conditions shall be read in conjunction with the other parts of the tender documents
viz. Trustees' General Conditions of Contract, drawings, if any and other documents forming part of the
contract.

Unless otherwise mentioned the work to be provided for by the contractor shall include but not be limited to the following:

- a) Provide all materials, equipment, workmen, supervision, services, scaffolding, temporary drainage, temporary fencing and temporary lighting as required for safety and work purposes etc. for the execution of the work.
- b) To take all the safety measures like using life jackets, helmets etc. required for such type of work and insure the labourers against any accident which may occur in the course of execution of the job, if required, at no extra cost.
- c) To cover all office/ household furniture with tarpaulin or similar type of cover when there is any chance of damage/ spoiling during the course of the work, if required or directed, at no extra cost.
- d) To make good any damage done to any property during execution of work at no extra cost.
- Work site: The work site shall be considered to be inside the Taratala quarters complex of KoPT at Kolkata under Railway division jurisdiction. All intending tenderers should visit the site of work and acquaint themselves with exact nature, scope & site of work before quoting the rates. No claims for any extra payment will be entertained under any circumstances after opening of the tender and at any stage during execution of the work excepting otherwise approved by Engineer or his representative.
- 3. Working Period: Normally the work will be carried out between 8am to 5pm on the Trustees' working days only. In case of any deviation from this, the contractor shall have to take prior permission from the Engineer or his representative. However, the tenderer should note that he might be required to carry out the job on Sundays, Holidays and after normal working hours and at night in addition to the normal working hours to expedite the progress of the work at times of requirement. The tenderer should include in his rates the cost, if any, involved on these accounts.
- 4. **Time of Completion:** The work is an one time one and shall have to be completed by 3(three) months from the date of placement of work order.
- 5. **Workmanship:** The contractor shall maintain workmanship of different items with an idea of providing a trouble-free service to the users of different facilities.
- 6. **Supervision:** The contractor shall have to engage sufficient number of qualified and skilled persons to supervise and execute the work. The contractor shall be solely responsible for any defective work as a result of poor supervision.
- 7. **Forwarding of Materials:** The contractor shall have to arrange transport for forwarding any usable/ saleable materials that may be found during the process of execution of the work to the Trustees' Sales yard or any other site/ godown including labourers, transportation, loading, unloading all complete as per the direction of the Engineer-in-Charge. No separate payment will be made to the contractor on this account unless specifically mentioned in the B.O.Q.
- 8. **Discrepancies in the contract documents:** The several documents forming the contract shall be taken, as mutually explanatory of one another and in case of discrepancies Bill of Quantities shall prevail over the Specifications and Special Conditions of Contract over the General Conditions of Contract. The Engineer's decision on this matter however, shall be final and binding and the tenderers' attention is drawn to clause 4.3 of the General Conditions of Contract in this respect."

- 9. Specifications/ Codes and Standards: All works under this contract will be executed according to the Trustees' Specification for materials and workmanship. Whenever the details are not specifically covered in the specifications, relevant provisions in the latest revision and/ or replacements of the Indian Standard Specifications (IS) or in absence CPWD specifications/ any other International Code of Practice will be followed. The Contractor shall have to procure copies of such codes/ standards for ready reference of his own personnel as well as the Trustees' Engineers at site at his own cost and without any additional reimbursement.
- 10. **Safety:** The contractor shall follow all safety precaution for prevention of injury or accidents and safeguarding human lives and property. Dock safety regulations, if applicable, shall be strictly observed and safety officers of the KoPT be accorded all facilities for inspection of the works etc. whenever so required. The contractor shall further comply with any instruction issued by the Engineer in respect of safety, which may relate to temporary or permanent works, working of tools, plants & equipments, means of access or any other aspect. The contractor shall provide all necessary first aid measures, rescue and life saving equipment, etc. in proper condition, which shall be readily available for use at all times. The contractor shall adopt all the above safety measures at his own cost.
- 11. **Protection of existing services:** The contractor must pay full attention to the fact that the existing service facilities for users are not disrupted at any time due to storing of materials etc.

The contractor shall be held liable for all damage and any unauthorised interference to the existing service caused by him during execution of works. Should any damage be done to the existing services, in general the contractor shall make good the same and do any further work considered necessary by the Engineer's representative without any delay; otherwise the cost of such repairing shall be recovered from his running bill for which the Engineer's decision shall be final and binding.

- 12. **Cleaning during execution and after completion:** On completion of the works the contractor shall reinstate and make good at his own expense any property or land which might have been disturbed and/ or damaged by his works. He should also clean the site as required during execution and fully clear the site after completion of all the works.
- 13. **Water:** Water required for drinking and other purposes and for works will have to be arranged by the tenderer at their own cost.
- 14. **Measurement and Payment**: The items/ quantities set out in the "Bill of Quantities" are the estimated items/ quantities of the work and they are not to be taken as the actual and correct items/ quantities of the works to be executed by the contractor in fulfilment of his obligations under the contract. However, the contractor will be paid as per actual work executed by him and under the provisions of the tender.
- 15. **Escalation/ variation in process:** No escalation/ variation on prices of labour as well as materials will be entertained.
- 16. Compliance to the Labour Laws and Contract Labour Regulation and Abolition Act, 1970: The contractor shall be required to comply with the Minimum wages Acts 1948, Employees Liability Act, 1938, Industrial Disputes Act, 1938, industrial Dispute Act, 1940 and The Contract Labour (Regulation and Abolition) Act, 1970, or statuary amendments and the modifications thereof, any other laws relating thereto and the rules made thereunder from time to time.

It will be the duty of the contractor to abide by the provisions of the Acts. Ordinances, Rules, Regulations, Bye-laws and procedures as are lawfully necessary in the execution of the works. The contractor will be fully responsible for any delay/ damage etc. and keep the Engineer indemnified against all penalties and liabilities of any kind for non-compliance or infringement of such Acts, Ordinances, Rules, Regulations, By-laws and Procedures.

The contractor shall indemnify the KoPT against payment to be made under or for the observance of the laws aforesaid without prejudice to his right to claim indemnity from his subcontractor.

The aforesaid regulations shall be deemed to be a part of this contract and any breach thereof shall be deemed to be a breach of contract. It will be obligatory on the part of the contractor to obtain necessary Labour License (if required) from the competent authority for deploying requisite Nos. of labours in the work and submit to the Engineer-in-Charge prior to commencement of the work.

- 17. Compliance of Building and other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and other Construction Workers' Welfare Cess Act, 1996:
 - a) The successful tenderer will be required to comply with the relevant provisions of Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act 1996 and West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act 2004 as well as Building and Other Construction Workers' Welfare Cess Act 1996 and the rules framed there under.
 - b) An amount of Cess calculated at the rate of 1% of the billed amount shall be progressively recovered from each running bill as well as from the final bill of the Contractor for onward transmission of the same to the appropriate authority.
 - c) Income Tax and other Taxes as applicable will be deducted as per rule.
